The 2019–2020 School Budget

A Message from Our Superintendent Dawn A. Santiago-Marullo, Ed.D. and Debbie Palumbo-Sanders, President, Board of Education

The 2018-2019 school year has been filled with many incredible achievements.

From impressive academic successes in the classroom to admirable extracurricular accomplishments in the arts, athletics and in the community, VCS students and staff exude excellence at every turn. This year, our District was honored on many fronts for this culture of achievement. *Buffalo Business First Magazine, US News and World Report* and *Niche.com* all named us a top school district in Upstate New York and *Niche.com* named us the number one school district for athletes in Upstate New York. Despite the many amazing accolades VCS has received, the heart of all of our success begins and ends with you.

VCS simply would not be the school district that it is today were it not for our entire community. Thanks to your continued support, we are an example of public education at is best.

In an effort to maintain our leading edge, VCS works carefully to create the best fiscal plan each and every year. The 2019-2020 budget is no different. In addition to supporting the intellectual, physical, and emotional well-being of all of our students, we are also dedicated to preparing a budget that is responsible and fair to our taxpayers.

The 2019-2020 Victor Central Schools' fiscal plan reflects this. Our proposed budget of \$73,732,603 includes an increase in building aid of \$1,451,672. This is the building aid we expected to receive from the state for our current capital project. When this aid and the corresponding debt is separated out, the budget-to-budget increase for 2019-2020 is \$2,904,789 or 4.19%, our proposed budget includes a true value tax rate of \$15.94 per thousand, down from last year's rate of \$16.14. For taxpayers, this rate equates to a 1.24% **decrease** from this year's true value tax rate.

At \$73,732,603 the 2019-2020 budget is both responsive and responsible. It allows us to add new and much needed positions across the District. For a complete listing of specific proposed positions, see page 10.

Building a school budget is no small feat. Each year, we are faced with both new and existing challenges, from shifts in student numbers and needs to outside governmental factors. Despite the landscape on which we build our budgets, we continue to remain true to our goals of providing every child with a high quality education while being fiscally responsible to our taxpayers.

We hope that you will take the time to review some of the finer points of the 2019-2020 budget in this publication. In doing so, we also hope that you agree that VCS continues to set the stage for success for our students, staff and entire community.



Bus Purchase Proposition

School bus fleet maintenance and safety are driving a bus purchase proposition on the ballot May 21, 2019. Residents will be asked to approve the purchase of five 77-passenger buses, one 30-passenger mini-bus and one 24-passenger wheel chair mini-bus.

The proposition totals \$859,661. New York State will provide 69% of the funding through NYS Transportation Aid. The new buses will replace vehicles that are at least 12 years old and have mileage in excess of one hundred thousand miles.

Notice is further given that a Bond proposition in substantially the following form shall be presented to the qualified voters of the district at such Annual District Meeting and Election.

Bond Proposition Resolved:

- (a) That the Board of Education of the Victor Central School District, in the Counties of Ontario, Monroe and Wayne, New York (the "District"), is hereby authorized to purchase various school buses and vehicles for use by the District; and to expend therefor, including preliminary costs and costs incidental thereto and to the financing thereof, an amount not to exceed the estimated total cost of \$859,661;
- (b) that a tax is hereby voted in the aggregate amount of not to exceed \$859,661 to pay such cost, said tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; and
- (c) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the principal amount of not to exceed \$859,661 and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.



Victor Central School 2019-20 Budget Revenue Plan



2018-19 True Tax Rate Comparison



The figures above represent the true value tax rate per \$1,000 of home assessment. In comparing the 2018-19 true value tax rates among Ontario County schools plus our contiguous and academic benchmark districts in Monroe County, Victor's true tax rate was the **lowest at \$16.14 per thousand**.

Should the 2019-2020 budget be defeated and a contingent budget be adopted, the Victor Central School District Board of Education will make the final determination of budget cuts in a contingency budget. The following is a list of options the Board may choose to eliminate or reduce: some athletic teams, administrators, teachers, support staff, and instructional programs. In addition, equipment purchases must be eliminated and all community groups will be required to pay for the use of buildings (please note that Section 2023 of the Education Law requires school districts to provide this statement of assumptions made in estimating the contingency budget).

A Budget Q & A

What is a tax levy?

A tax levy is the total sum of money raised by a school district after subtracting out all other sources of revenue, including state aid. The tax levy is used to determine the tax rate for property owners.

What is a tax rate?

A tax rate is the amount of taxes paid by property owners for each \$1,000 of assessed value of their property. Tax rates paid by individual taxpayers may differ greatly from one household to another, based on such things as equalization rates and assessed property values.

What is the New York State Property Tax Cap?

New York State's Property Tax Cap law establishes an annual tax levy limit for each school district. The tax levy limit allows school districts to increase their property tax levy from one year to the next by the lesser of two percent or the rate of inflation, with some exceptions, based on a multi-step formula. The law does not restrict proposed tax levy increases to two percent however it does determine the level of voter support needed for a school budget to pass.

What is the New York State Property Tax Relief Credit?

If you currently receive your STAR benefit as a reduction on your school tax bill (the STAR exemption), you may receive a greater benefit if you switch to the STAR credit to receive a check instead.

Recent changes in the law beginning this year:

- The value of the STAR credit may increase by as much as 2% each year, but the value of the STAR exemption will not increase.
- The income limit for the Basic STAR exemption is now \$250,000.
- If your income is more than \$250,000, you must switch to the STAR credit.
- If your income is \$250,000 or less, you have the option to switch.

Traffic Control Attendants Drive Home Safety

and Have Fun Doing It!



In September, 2016, VCS implemented a new facet to morning and afternoon drop off and pick up times when they hired a team of traffic control attendants. Chris Marshall, Director of Facilities and Operations at VCS said the new addition was driven by several factors, mainly the increase of campus traffic. While the initial introduction of our new yellow vested friends was met with some question and curiosity, the team was quickly embraced by students, staff and parents alike, because what they do is invaluable to all of us.

"The role of our traffic control attendants is two-fold: to get students and staff into buildings safely, and to keep traffic flowing," Marshall said. They also help with parking at special events.

While safety and traffic flow are the crew's top priorities, Marshall said, the group, comprised mostly of retirees, quickly discovered the job offers much more.

After all, why would someone in the comfort of retirement want to get up early and go to school again? The reasons are many.

VCS class of '68 graduate Dick Crowley and retired United States Postal worker said he took the job not only because he likes the flexible hours, but because he missed the interaction with adults and children.

Don Grundke, a former sales manager, agrees the flexible hours and socialization are great motivators. "Working with the other guys has proven to be fun. We come

from many different backgrounds and have a good time together at work and outside of work!"

After forty years as the owner of a construction company, Jim Weld is having a great time building relationships. "The best part of this job is interacting with the parents, staff and all the students from high school down to the little ones at the Victor Early Childhood School. We strive to communicate to everyone that the safety of all children is our priority," he said.

Tony Alfieri ran two and four color offset printing presses for forty years before he retired. Today, he enjoys being a traffic control attendant because it performs a valuable service and is a great way to mingle with students and parents. "I like the people I work with and we have a great time all the time! We also like the way the parents respect us," he said.

2019 Volunteer of the Year Named


