District residents will cast ballots on the proposed 2017 – 2018 budget at the annual budget vote and Board of Education election on **Tuesday**, **May 16**. Voting will take place in the **Victor Intermediate School Auditorium** from 6:00 a.m. to 9:00 p.m. Voters must be at least 18 years old, a registered voter and a resident of the District for at least 30 days prior to May 16, 2017.

On Tuesday, May 9, 2017, the Victor Central School District will hold voter registration from 3:00 to 7:00 p.m. in the District Office Conference Room. This registration is for residents currently not registered to vote in the general election.

The 2017–2018 School Budget

A Message from Our Superintendent Dawn A. Santiago-Marullo, Ed.D.



Thank you for your continued support of Victor Central Schools' students and staff. This year, I am pleased to report that we are proposing yet another budget that demonstrates fiscal responsibility to the community and a continued commitment to providing our students with the highest quality education possible.

Between a reduction in expenses, mainly from teacher retirement system costs, and additional New York State aid, I am pleased to report that the 2017-2018 Victor Central Schools' fiscal plan reflects a budget-to-budget increase of \$1,250,015 or 1.92%. It also includes a true value tax rate of \$16.32 per thousand. For taxpayers, this rate translates into a 0% increase from this year's true value tax rate.

At \$66,352,887 the 2017-2018 budget allows us to add several much needed positions that were lost or put on hold during the recent recession. In fact, each of our five schools, from the Early Childhood, Primary and Intermediate Schools to the Junior and Senior High Schools is on track to add positions. This includes teachers, typists, counselors, cleaners and support staff, to name a few. (For a complete listing of proposed positions, see page 9.)

Formulating a budget is never an easy process. There are so many variables, some of which are completely out of our control, but as always, VCS continues to build budgets with two goals in mind, to provide every child with the highest quality education and to remain fiscally responsible to our taxpayers. I am proud to present the 2017-2018 to you in this publication not only because it paints a thoughtful budget development process but because it tells a story of a school community working together and striving for excellence.





Bus Purchase Proposition

School bus fleet maintenance and safety are driving a bus purchase proposition on the ballot May 16, 2017. Residents will be asked to approve the purchase of six 77-passenger buses.

The proposition totals \$847,000. New York State will provide more than 60 percent of the funding through NYS Transportation Aid. The new buses will replace vehicles that are at least 13 years old and have mileage in excess of one hundred thousand miles.

Notice is further given that a Bond Proposition in substantially the following form shall be presented to the qualified voters of the District at such Annual District Meeting and Election.

Bond Proposition Resolved:

- (a) That the Board of Education of the Victor Central School District, in the Counties of Ontario, Monroe and Wayne, New York (the "District"), is hereby authorized to purchase various school buses for use by the District, and to expend \$847,000 therefor;
- (b) that a tax is hereby voted in the aggregate amount of not to exceed \$847,000 to pay such cost, said tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; and
- (c) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the principal amount of not to exceed \$847,000 and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.


Budget Proposition



2016-17 True Tax Rate Comparison



The figures above represent the true value tax rate per \$1,000 of home assessment. In comparing the 2016-17 true value tax rates among Ontario County schools plus our contiguous and academic benchmark districts in Monroe County, Victor's true tax rate was the **lowest at \$16.32 per thousand**.

STAR Program Information

The NYS School Tax Assessment Relief (STAR) program provides qualified homeowners with a \$30,000 assessment reduction for tax purposes. Senior citizens receive a \$65,300 exemption. More than 900 senior citizens throughout the District received a reduction in their tax bills for the 2016-2017 school year.

Should the 2017-2018 budget be defeated and the above contingency budget be adopted, the Victor Central School District Board of Education will make the final determination of budget cuts in a contingency budget. The following is a list of options the Board may choose to eliminate or reduce: some athletic teams, administrators, teachers, support staff, and instructional programs. In addition, equipment purchases must be eliminated and all community groups will be required to pay for the use of buildings (please note that Section 2023 of the Education Law requires school districts to provide this statement of assumptions made in estimating the contingency budget).

A Budget Q & A

What is a tax levy?

A tax levy is the total sum of money raised by a school district after subtracting out all other sources of revenue, including state aid. The tax levy is used to determine the tax rate for property owners.

What is a tax rate?

A tax rate is the amount of taxes paid by property owners for each \$1,000 of assessed value of their property. Tax rates paid by individual taxpayers may differ greatly from one household to another, based on such things as equalization rates and assessed property values.

What is the New York State Property Tax Cap?

New York State's Property Tax Cap law establishes an annual tax levy limit for each school district. The tax levy limit allows school districts to increase their property tax levy from one year to the next by two percent or the rate of inflation, whichever is less, based on a multi-step formula. The law does not restrict proposed tax levy increases to two percent however it does determine the level of voter support needed for a school budget to pass.

What is the New York State Property Tax Relief Credit?

If you are a homeowner receiving a STAR benefit and your locality and school

district have kept tax increases under the tax cap, you may be eligible for the NYS Property Tax Relief Credit. Qualifying New York State homeowners must also:

- Receive either the Basic or Enhanced STAR property tax relief
- Have an income of \$275,000 or less
- Have paid school property taxes in 2016

Beginning in 2017 the property tax relief credit will be a percentage of a homeowner's STAR benefit, with lower incomes receiving a higher percentage benefit.

Students Share Their Thirst for Helping Others Through Ugandan Water Project

This past January students in Mr. Muscarella's Global 10 classes got an eye-opener after seeing a presentation on the Ugandan Water Project (UWP), a local non-profit group dedicated to bringing clean water to the people of Uganda. Students saw videos and heard from UWP staff member Megan Busch about the dire need for clean water where children often walk hours a day to collect water for their villages.

Tenth grade student Joelymar "Jelly" Ruiz was so inspired by the story that she asked English Speaker of Other Languages (ESOL) teacher Laurie Estochen to help her start a campaign to raise money and awareness for the cause with the support of the Senior High Global Competency and Key Clubs. Preparation for the fundraiser was intense, but Jelly, along with her fellow English Language Learners (ELL) students, Ismeydi Cordero and Kataichiry

"Katai" Rohena-Marquez, were determined to make it happen.

"Jelly, Ismeydi and Katai worked hard with club advisors to arrange meetings with staff from UWP to outline a fundraising plan, which ultimately included Mr. Muscarella and the Social Studies department," Estochen said.

Their hard work paid off. On Thursday, March 9th, Jelly and her team implemented phase one of their fundraiser with a kick-off meeting featuring James Harrington, UWP Director. During this meeting, Harrington talked to students about his experiences in Uganda and described how young children walk hours a day to get water for their families instead of going to school. He also described how the water they have is not clean. At the end of the session Harrington challenged VCS students to raise enough money (\$3,500) to buy a rainwater collection tank and a filter to process the dirty water, an investment that would mean a group of young Ugandan children would never have to walk for water again.

Estochen said the students immediately rose to Harrington's challenge and worked for more than two weeks collecting donations from VCS friends, family and staff. To date, the project has raised \$4142.25!

The culminating event of the VCS
Ugandan Water Project fundraiser was
a symbolic "water walk" on Wednesday,
March 29th. During this walk, students,
staff and UWP representatives carried big,
heavy jugs of water around the Senior
High school to gain a better understanding
of what Ugandan children endure. Estochen said that all during the walk students
held tight to the phrase; "We are walking,
so other kids don't have to."





District Treasurer Lynne Lubaszewski Is All Business, And Then Some



Thousands of students and staff may set the scene for a typical school day at Victor Central Schools but there is one little known person who works quietly behind the scenes to help ensure their success every day, our District Treasurer, Lynne Lubaszewski.

2017 Volunteer of the Year Named

93 Year Old Eleanor Barry Vital to the Vote

Victor resident Eleanor Barry was honored with the 2017 Volunteer Committed to Service award at a special recognition ceremony in the JH/SH arts center on March 24th during Victor Central Schools' spring staff conference day.

Her nominator, Victor Central Schools' District Clerk Maureen Goodberlet said Barry's tireless commitment to the VCS voting process which includes an annual vote, Board of Education elections, capital project votes, voter registration and Victor-Farmington library votes is simply astounding.

"Eleanor has been the chairperson of the annual vote and election, Victor-Farmington Library vote (which is also run by VCS) and various capital project votes for well over twenty years. Sometimes there can be as many as three votes in a year. Eleanor is also an instrumental part of voter registration for every vote that takes place. These are paid positions and Eleanor has always volunteered her time, not taking a penny," Goodberlet said.

Goodberlet attributes Barry's wealth of knowledge in an age of ever changing State and Education Law voting procedures and her attention to detail to the success of Victor Central Schools' votes. "On the day of the vote Eleanor doesn't think twice about working a 16 hour day, even at her current age of 93. She comes in around 5:00 a.m. to make sure voting machines are up and running and supplies are set up appropriately. She works all day troubleshooting situations that arise with voter registration and voting machines and then closes the polls at 9:00 p.m. After the polls are closed she helps to verify the final numbers and presents results to those in attendance." Goodberlet said.

Goodberlet, who has been managing school votes for ten years, said she continues to be amazed at how the efforts of one person can make a difference in how smoothly a vote runs, impacting tens of thousands of voters through the years. "Eleanor has



earned the respect and gratitude of not only those of us who have the great privilege or working with her, but our entire Victor Central Schools' community," she said.

The Volunteer Committed to Service award was created in 2009 by Victor Central Schools and the Victor Teachers' Association as a way to pay tribute to those special men and women who give of their time and talents to VCS, whether through one major event or years of service to a group of students or a building.

Victor Central Schools' Lead Water Testing Complete

Last March, following the Flint, Michigan water lead tainting scandal, Victor Central Schools joined thousands of schools nationwide in voluntarily testing the quality of its water. On September 6, 2016 Governor Andrew Cuomo signed legislation that made water testing in schools mandatory. This past December, Victor Central Schools completed testing water samples for lead in all its buildings, grades Pre-K through 12. Of the 807 samples taken only 100 exceeded the 15 parts per billion (ppb) threshold set by New York State law. All of the faucets and water fountains in question have been, or are in the process of remediation and retesting.
