



DAVIS SCHOOL DISTRICT COVID-19 Diagnostic Test Consent Form

Statement of Purpose and Intent

In accordance with [Utah State Public Health Order 2020-25 Temporary Statewide COVID-19 Restrictions](#), a person may not participate in a high-school-sponsored social gathering that is an athletic or extracurricular activity, including a competition or practice, unless:

- 1) beginning no later than November 30, 2020, the high school verifies that each participant received a diagnostic test approved by the United States Food and Drug Administration to determine current COVID-19 infection within the 14 days immediately prior to the athletic or extracurricular activity; and
- 2) immediately prior to participating in the athletic or extracurricular activity, each participant confirms that the participant:
 - a) has completed any quarantine or isolation period required by the [COVID-19 School Manual](#); and
 - b) is not experiencing any symptoms of COVID-19.

By signing below, I attest that:

- I have signed this form freely and voluntarily, and I am legally authorized to make decisions for the student named above.

- I understand that my student will be tested every 2 weeks for the duration of the athletic or extracurricular activity he/she is participating in.
- I understand that if I revoke my consent or refuse to sign, my student will not be allowed to participate in the athletic or extracurricular activity.
- I understand that my student's test results will be disclosed to myself, a school administrator, the activity supervisor, and the Davis County Health Department.
- I understand that if the test result is positive my student shall be subject to the isolation period required by the COVID-19 School Manual.

Definitions

“Extracurricular activity” means an activity, a course, or a program that is: 1) not directly related to delivering instruction; 2) not a curricular activity or co-curricular activity; and 3) provided, sponsored, or supported by the District.

“Co-curricular activity” means an activity, a course, or a program that: 1) is an extension of a curricular activity; 2) is included in an instructional plan and supervised or conducted by a teacher or education professional; 3) is conducted outside of regular school hours; 4) is provided, sponsored, or supported by the District; and 5) includes a required regular school day activity, course, or program.

“Curricular activity” means an activity, a course, or a program that is: 1) intended to deliver instruction; 2) provided, sponsored, or supported by the District; and 3) conducted only during school hours.

School Testing Site Information

The Davis School District has set up rapid testing sites at each high school for students who are participating in District sponsored athletic or extracurricular activities to get testing every 2 weeks.

The federally funded Abbott BinaxNow rapid antigen tests will be administered by school nurses at each site. Results can be seen within 15 minutes without the use of laboratory equipment. Check with your high school for its testing schedule.

Once the COVID-19 Diagnostic Test Consent form has been signed by a parent and received at the school, a student may be tested at the school site without a parent present.

Records maintained by the District related to COVID-19 diagnostic testing will be retained until administrative need ends, then destroyed.
