The public comment window for email submissions will open at 8:00 a.m. on December 14, 2020, and closes at 3:30 p.m. on December 15, 2020. Public comments will be compiled and processed prior to the start of the Personnel Commission meeting to the greatest extent possible.

Public comments received via email will be compiled, presented to the Personnel Commission members for review prior to or during the meeting, read aloud by the Personnel Commission at the meeting during the designated public comment period, and included in the minutes for the meeting when published. If any member of the public wishes to comment on a specific agenda item, the member of the public must include the agenda item in the subject line of the email. Public comments that are outside of the Personnel Commission's subject matter jurisdiction will be excluded. Procedures applicable to public participation as including, but not limited to, speaker time limits, shall be enforced to the greatest extent possible.

The above temporary procedures will modify the usual public comment procedures published in the Agenda until further notice. In compliance with the Americans with Disabilities Act, those requiring special assistance to access the livestream of the meeting, to access written documents being discussed at the Personnel Commission meeting, or to otherwise participate at Personnel Commission meetings; please contact Juris Burgos, Coordinator of Personnel, at jburgos@tcusd.net.
