

Tuition & Fees 2021/2022



School fees are made up of Tuition, Family Membership, Capital Improvement Fee and various other items, as listed.

A. Tuition

Alberta Residents: Total \$18,930

These fees are to be paid by selecting one of the payment options listed below. Note: a surcharge is levied for each of the extended payment plans. Tuition deposits paid prior to start of school are non-refundable.

B. Family Membership

Pursuant to the by-laws of the Society, each Parent (as defined therein) with at least one child registered at the College, may become a member of the Society by executing this agreement and remaining in compliance with the terms hereof.

PRIVILEGES:

It is standard common practice among Independent Schools to incorporate a "family membership fee" or "new student fee" into the admissions process. At WIC, it is a one-time, non-refundable fee of \$3,500. It is paid at the time of registration of the first family member and extends thereafter to all siblings who qualify for the College's program.

C. Capital Improvement Fee

To ensure the continuous improvement of the facility, each family is levied a one-time Capital Improvement Fee (CIF) of \$3,500 paid at the time of registration of the first family member entering WIC. The CIF extends thereafter to all siblings who qualify for the College's program.

D. Grade 9 and Grade 12 Graduation Fees

\$100 for Grade 9 Graduation, if applicable.

\$300 for Grade 12 Graduation, if applicable.

E. School Supplies and Optional Activities Fees

School supplies are the responsibility of the student, as many courses require specific materials. Until teachers have provided specific supply lists, a binder with loose leaf paper will suffice. Optional Activities Fees are collected for items such as sports teams, optional camps/trips, merchandise, etc.

Bring Your Own Device (BYOD) - Grades 7 to 12 (effective for 2021/22 school year)

All WIC students will be expected to bring their own devices (BYOD) to school and use their technology resources to support their learning. Please refer to the information found on the WIC [website](#).

Students will be responsible for maintaining their own device including charging and installing virus protection. If students are unable to bring their own device, they may sign out a computer from the College on a short-term basis.

An important component of BYOD will be the education of students around appropriate online behaviours. We will review cyber-safety rules with students frequently throughout the course of the school year and offer reminders and reinforcement about safe online behaviors.

Students will also be expected to comply with all class and school rules while using personal devices. The use of technology is not a necessity but a privilege and provides a distinct advantage when it is used effectively. When abused, privileges will be questioned, and sanctions will be administered. Students will not only learn technology skills but will develop the self-regulation skills required to be successful.
