1. Choose a vendor from the list below to work with.
2. Contact Ashley Nobles at LRS (504-473-6759) to let her know which vendor you'd like to work with. She will complete a referral and send it to the vendor. Once the vendor receives the referral, they will contact you to schedule a community based assessment.
3. Community Based Assessment. The vendor will meet with your student to complete an assessment in two different environments and get a better idea of where the student wants to work and what skills/strengths the student possesses.
4. Job finding process. The vendor will work with your student to find a job that he/she is interested in. This process includes updating and refining resume, completing job applications, and support with job interviews.
5. Begin the job. Once a student has successfully landed a job, the vendor may assist them with orientation (some vendors provide orientation help, others do not.) The vendor will provide a job coach that will check in with the student at their work site. The frequency of check-ins varies depending on the vendor.
6. Establish job stability. Once the vendor determines that the student is stable in his/her job, they will close out the student's case. Typically, the student must maintain his/her job for one year to establish stability, though this can vary depending on the vendor.
