The Head of the Middle School Deans, and works with the Director of Social and Emotional Learning, Registrar, School Counselors, Librarian, Learning Specialist, Middle School Athletic Director, and the Program Directors to implement curriculum and programs appropriate for the Middle School Deans, communicate with parents regarding Middle School issues and concerns. The Head of the Middle School plays an active role with the Admissions team and on the Middle School Admissions Committee.
