Mayor Daniel A. Champagne called the public hearing/annual town meeting to order at 7:00PM.

There were approximately 84 persons present at the Annual Town Meeting including the Mayor, Members of the Town Council, and staff.

Town Clerk, Karen Daigle read into record the legal notice of the Public Hearing/Annual Town Meeting and certified the notice was posted in the lobby of Town Hall, outside bulletin board and on the town website on April 15, 2019 and published in the Journal Inquirer in the April 17, 2019 edition.

Mayor Daniel A. Champagne thanked the Superintendent, Dr. Joseph McCary, the Assistant Superintendent Robert Testa, and members of the Board of Education for the Shared Services work with the Town of Vernon.
