

**INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT  
FOR COOPERATIVE PURCHASING CONTRACTS FROM VANCOUVER SCHOOL  
DISTRICT NO. 37**

Pursuant to RCW chapter 39.34, 28A.320.080 and other related provisions of Washington law, **Vancouver School District No. 37** and **Kennewick School District No. 17 (Purchasing Agency)**, hereby agree to enter into this agreement for the cooperative purchasing of furniture, supplies, equipment and/or services upon the following terms and conditions:


1. Vancouver School District No. 37 and Purchasing Agency are duly constituted school districts and political subdivisions within the States of Washington.
2. Vancouver School District No. 37 solicits competitive contracts with various vendors for the purchase of furniture, supplies, equipment, and/or services. Vancouver School District No. 37 agrees to extend the terms and conditions of said contract(s) to the Purchasing Agency, to the extent permitted by law.
3. Vancouver School District No. 37 agrees to comply with statutory requirements under Washington law regarding notice of bids for proposals for goods and services subject to this agreement. Purchasing Agency accepts responsibility for compliance with any additional or varying laws or regulations governing purchases on behalf of Purchasing Agency.
4. Whenever Vancouver School District No. 37 contracts to purchase furniture, supplies, equipment, and/or services on behalf of other political subdivisions, Purchasing Agency may also purchase furniture, supplies, equipment, and/or services at the same terms and conditions as Vancouver School District No. 37.
5. Vancouver School District No. 37 accepts no responsibility for the performance of the vendor in any contract entered into as a result of the cooperative bid; makes no warranty, express or implied, for any materials or services acquired under this agreement; and accepts no responsibility for the payment of the contract or purchase price by the Purchasing Agency.
6. Purchasing Agency reserves the right to contract purchases independently with or without notice to Vancouver School District No. 37.
7. This Agreement shall continue to be in full force and effect until terminated by either party by written notice to the other party.
