

Please complete all information on the Transportation Request Form (Part 2) and return **both Part 2 and Part 3** in an envelope and mail it to the **Bayport-Blue Point School's Transportation Office before April 1, 2021.**

Upon receipt by this office, Part 3 will be stamped, dated and returned to you by mail. If you have not received Part 3 by March 13, 2021, we suggest that you call our office to verify that we have received your request. **A Transportation Request Form must be completed for each child in your family that will attend a non-public school during the 2021-2022 school year.** By law, a new request form must be filled out each year. Transportation is not automatically continued from school year to school year.

We strongly recommend that if you are filing this form after March 13, 2021 you either hand deliver or return the form by certified mail. **A copy of an original birth certificate is required for all incoming Kindergarten students.**

**District Transportation Policy – Non Public Schools  
School Year 2021 - 2022**

In accordance with Education Law & Board of Education policy, all residents of the Bayport – Blue Point School District requesting transportation for their child (ren) to attend a non-public school must submit this request no later than April 1<sup>st</sup> 2021 in order to be eligible for transportation during the 2021 – 2022 school year. **Requests or changes submitted after the April 1<sup>st</sup> deadline, will not be honored if an additional district expense would be incurred by granting the request.** Proof of residency in the Bayport – Blue Point District will be required for all new applications.

A copy of an original birth certificate must be submitted for all incoming Kindergarten students. Children eligible for kindergarten must be 5 years of age before December 1<sup>st</sup> 2021.

Grades 6 through 8 .....2 miles  
Grade 9 through 12 .....2 miles
