

Outdoor Contact Sports Opt-In Form

Updated 2/16/2021

This form is to be used by a school located in a county designated as High Risk or Extreme Risk to notify of its intent to opt in to offer outdoor contact sports for the 2020-21 school year in accordance with the Governor's February 10, 2021 update to <u>Outdoor Contact Sports Guidance</u>. Once final, this form will be posted to a school or district website and a link to it will then be sent to ODE.

In Lower Risk and Moderate Risk counties, practices and games for outdoor contact sports, including high school football, can resume following health and safety guidance to be issued by the Oregon Health Authority.

In High Risk and Extreme Risk counties, where COVID-19 remains more widespread, schools and other sports organizations can opt-in to resuming outdoor full contact sports with additional protocols in place. In such counties, sports organizations must offer on-site responsive testing for symptomatic individuals and close contacts, contact information for contact tracing, and a waiver identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19. Schools in Extreme and High Risk counties must also have at least limited in-person instruction occurring, with the goal of achieving hybrid or full in-person instruction for students this school year. Schools must also be in compliance with state guidance for COVID-19 testing.

COVID-19 testing will be monitored by school nurse, Lori Haslam, RN.

When an athlete or coach develops symptoms consistent with COVID-19, testing will be used to inform their care and return to practice/school. Any symptomatic individual who is tested must leave school/practice immediately and not return until allowed by the RSSL guidance.

When a team cohort has been exposed to case of COVID-19 they will be quarantined; testing on day 5 through 7 following exposure may be used to facilitate early release from quarantine after day 7 when recommended by Benton County Health.

COVID-19 Waiver Philomath School District 17J

Waiver of Liability and Hold Harmless for communicable diseases, including COVID-19

The Novel coronavirus (COVID-19), has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. While rules, guidance, and personal discipline may reduce this risk, the risk of serious illness and death does exist. Philomath School District 17J ("District") cannot completely mitigate the transfer of communicable diseases like COVID-19 especially when involved in athletic activities. Participation in athletic activities includes possible exposure to and illness, injury, or death from infectious diseases including COVID-19.

In consideration for providing my child the opportunity to participate in athletic activities and any related transportation to and from athletic events, both my child and I voluntarily agree to waive and discharge any and all claims against the District and release it from liability for any exposure to or illness or injury from infectious disease including COVID-19, including claims for any negligent actions of the District or its employees or agents, to the fullest extent allowed by law, for myself, my child, our estates, our heirs, our administrators, our executors, our assignees, and our successors.

I also agree to release, exonerate, discharge and hold harmless the District, its Board of Directors, the individual members thereof, and all officers, agents, employees, volunteers, and representatives from all liability, claims, causes of action, or demands, including attorney fees, fines, fess, or other costs (e.g. medical costs) arising out of any exposure to or illness or injury from infectious disease including COVID-19, which may result from or in connection with my child's participation in athletic activities.

I certify that I have read this document in its entirety and full understand it contents. In exchange for the opportunity to participate in the athletic activities, the above-names student and I freely and voluntarily assume all risks of such hazards and notwithstanding such, release the District from all liability for nay loss regardless of cause, and claims arising from the student's participation in the athletic activities.
