BOND UPDATE #21

Here's what's been going on during the past week:

- 1. The big news this week is that we have been approved to use General Contractor/Construction Manager, or GC/CM, process for the design and construction of the new Ferndale High School. The General Contractor/Construction Manager method allows the general contractor to participate as an adviser during the architects' design of a major construction project. This improves communication, because the general contractor can provide input on the availability and cost of suggested materials and perhaps offers cheaper alternatives. The GC/CM method will cost the school district a little more upfront for the general contractor's time, but in the long run the contractor's suggestions about the affordability of different designs can save us significant dollars. - 2. Now that we are approved for use of GC/CM project delivery, we will be beginning the selection process for a GC/CM contractor. This will be a three-part process: (1) requesting qualifications (RFQ) from interested contractors, (2) conducting interviews with the most qualified, and then (3) inviting our top-selected contractors to submit proposals (RFP). The goal is to have a GC/CM contractor selected for approval by the School Board at their October 2019 meeting.
- 3. The Bond Oversight Committee met on Tuesday, July 23 at Mountain View Elementary. As a reminder all meeting information including agendas and meeting minutes can be found here: https://www.weareferndale.org/committee/
- 4. As a reminder, the Bond Oversight Committee is made up of seven independent Ferndale School District residents. Committee Member Ryan Kimball will be re-locating outside of the School District and vacating his current position on the Committee. As a result, current alternate member Brian Lynch will become a voting member, and the Committee has announced its intention to recruit an additional alternate member. - 5. Our pre-design consultants have been busy taking advantage of these summer months when the Ferndale High School campus is mainly unoccupied. Most of the due diligence and preliminary site investigation activities should be wrapped up within the next 4-6 weeks. Here is an overview of those activities:
 - a. Surveyors field work is under way
 - b. Transportation/Traffic data gathering is completed; analysis is in progress
 - c. Wetlands initial reconnaissance report is complete

- d. Environmental Phase 1 Environmental Site Assessment is complete
- e. Geotechnical soil borings and installation of ground water monitoring wells is complete; analysis is in progress
- f. Archaeological site investigations started this week
- 6. To date, we have received 29 applications for the Design Advisory Committee (DAC). We will continue to accept applications through July 31. You can access the application form here. All who apply will be notified of the final committee list no later than August 5. The first DAC meeting is scheduled for August 13.
