STUDENT REPORTS

Mr. Langendoerfer and Ms. Carroll provided Board updates pertaining to: winter sports, CIAC sportsmanship conference, senior class activities and student excitement of possible return to full time in-person learning model as soon as safely possible. Questions and brief discussion followed.

Mr. Amara and Mr. Franklin provided a Social Justice and Anti-Racism overview presentation and update of their work in both the High School and Middle School in order to prepare students for a diverse world and learn about different cultures, perspectives, civic duty, and respectful engagement regarding political discourse. Questions and discussion followed, and Ms. Sexton Read expressed grateful appreciation for the important and challenging work of addressing difficult conversations and exchange of ideas and value to students being given opportunities to engage, listen, consider, and articulate their experiences. Both Xavier and Alexa expressed appreciation for this work and spoke about the benefits to students and the school when given the opportunity to engage in these important issues.

Dr. Palmer provided Board of Education updates pertaining to: return to full, in-person learning model planning, parent survey, vaccine update, Kindness in Motion, and grateful appreciation for Dave Houldcroft and support staff in STEP, the program that is helping to keep our high school students on target with their credits.
