RECOMMENDATION: To approve an agreement with Project Beacon to increase the capacity, availability, and accessibility of COVID-19 testing in Tulsa Public Schools by creating a data platform that allows for the reporting of testing and test results according to state requirements.

FURTHER RECOMMEND: The attorneys for the school district prepare/approve the appropriate contract documents(s) and the proper officers of the Board of Education be authorized to execute the document(s) on behalf of the district.

RATIONALE: The Project Beacon COVID-19 testing pool provides our health care staff performing rapid tests with a safe, secure, and simple way to track and report test results being conducted at over 70 sites. This application also allows staff, students, and families to track their scheduled testing days and past test results. This tool is HIPAA compliant and has been purpose-built for the BinaxNOW rapid testing strategy that Tulsa Public Schools is implementing. The features of this tool are essential to allow us to expand rapid testing

across additional staff and students while ensuring that results are accurately recorded in real time. The current test provider BinaxNOW does not have the capabilities to report on this data, and the Tulsa Health Department has identified Project Beacon as the best provider for this service. The platform also enables the district to send the notification directly to the employee or parent (if the student is being tested). Project Beacon is a nonprofit organization focused on helping to increase the capacity, availability, accessibility, and affordability of COVID-19 testing. This platform and agreement with Project Beacon are part of the partnership between Tulsa Health Department and Tulsa Public Schools to implement rapid testing to support a safe return to in-person learning, and it is funded by the grant awarded to the Tulsa Health Department by the Rockefeller Foundation. Pathways to Health Community Partnership, LLC (an organization affiliated with the Tulsa Health Department) will be billed directly for these services.
