## SECONDARY SCHOOLS LEARNING PLAN UPDATE: Grade 5-12 Hybrid Students

**FEBRUARY 26, 2021** - The district sent an email communication to all families on February 26, 2021 regarding an update for middle school (Grade 5-8) and high school (Grade 9-12) students who are currently participating in the hybrid learning model. Students who are enrolled in full distance learning and students who are enrolled in the Area Learning Center will not be impacted by this learning update.



It was almost a year ago that schools in Minnesota began the process of transitioning to distance learning as a means of mitigating the spread of the coronavirus. We have come a long way since then and we are beginning to see the light at the end of the tunnel; positive COVID-19 cases continue to decline, and vaccines are now available.

As you know, Governor Walz announced recently that secondary school students could return to learning at school in hybrid models. At Fridley, students in grades 5-12 in the hybrid learning model have been learning at school two-days a week since February 16.

Beginning March 15, Fridley Middle School and Fridley High School students in Grades 5-12, who are currently enrolled in the hybrid learning model, will transition to learning at school four-days a week. Students will attend school in-person on Monday, Tuesday, Thursday and Friday. Wednesday will serve as a distance learning day with potential opportunities for students to participate in some on-site activities.

### The education of our students is a priority

Throughout this pandemic, our most important priority has been the continuation of the education of our students in the safest way possible. When making the decision to increase the number of days our older students spend learning at school, the district considered the following:

- Guidance from the state regarding in-person learning for secondary students
- Declining rates of positive COVID-19 cases in Anoka County
- Opportunity for district staff to be vaccinated at an on-site vaccine clinic organized and hosted by Fridley Public Schools and Anoka County Health Department.
- District continues to follow guidelines created to help maintain safety such as sanitation, face masks, saliva tests for staff, nightly fogging of classrooms, and providing hand sanitizer stations in each building.
- The Fridley School District has installed Needlepoint Bi-Polar Ionization Air Cleaning Devices (NPBI - ION) in all the air handling units in each building. The technology safely cleans the air inside each building.
- Continuation of full distance learning for students who prefer learning remotely.

### Safety of students and staff is very important to us

We have followed state recommendations on mitigating the spread of the virus, which include recently updated guidelines in the state's Safe Learning Plan. In addition, Fridley will also continue with the following safety protocols that we have been practicing in our schools and buildings:

- Maintaining physical distancing among students
- Face masks for students and staff
- Continuing to provide bi-weekly on-site saliva testing for staff
- Daily sanitation of classrooms and offices
- Limiting large group gatherings
- Continue to monitor local and state level data on COVID-19 positive rates.

Fridley Middle School and Fridley High School will be sending additional information to families soon. Your support throughout this process is appreciated.

**JANUARY 26, 2021** - The district sent an email communication to all families on January 26, 2021 to announce its return to in-person learning update for grades 7-12 at Fridley Middle School, Fridley High School and Area Learning Center.

It has been a few months since rising COVID-19 cases forced many schools across the state to transition to full distance learning. We have missed our students and are looking forward to welcoming them back at school. We are committed to supporting the needs of our students during this transition period as they return to learning in-person at school.

### **FEBRUARY 2021**

**FRIDLEY MIDDLE SCHOOL GRADES 7 AND 8**
  - All Fridley Middle School students in grades 7 and 8 will return to hybrid in-person learning at school.
  - All Fridley Middle School students in grades 5 and 6 will continue to follow their hybrid learning schedules
  - All students will participate in distance learning on Wednesday
  - All students who chose full distance learning for Semester 2 will remain in distance learning

### **AREA LEARNING CENTER**

- ALC students will return to half days in-person learning, five days a week on Monday-Friday.
- All students who selected full distance learning will remain in distance learning.

### **FRIDLEY HIGH SCHOOL**

- FHS students in Grades 9, 10, 11, and 12 will return to hybrid in-person learning at school.
- All students will participate in distance learning on Wednesday.
- All students who chose full distance learning for Semester 2 will remain in distance learning

**REMEMBER:** All full distance learning students who selected Fridley Online Academy for Semester 2 are NOT be affected by these changes.





## **CONTINUED SECONDARY SCHOOLS LEARNING PLAN UPDATE:**

### **JANUARY 26, 2021 UPDATE CONTINUED -**

As we communicated earlier in an update regarding our elementary schools, the decision to shift learning plans depends on COVID-19 data as well as other local and district factors.

We have been carefully monitoring the declining numbers of positive COVID-19 cases in Anoka County and are hopeful that the numbers will continue to decline. We will continue to follow health and safety guidelines and recommendations from our local and state health officials such as wearing face masks, hand washing, sanitizing, and deep cleaning to help keep our environment safe.



## **GUIDELINES TO HELP MAINTAIN SAFETY OF STUDENTS AND STAFF:**

The district will continue to monitor COVID-19 cases in Anoka County and the City of Fridley. As students and staff return to school in-person, we will follow recommended guidelines to help keep students and staff safe, including:

- All students will be required to wear face masks while inside school buildings.
- All staff will be required to wear face masks while inside school buildings, and are encouraged to wear face shields in addition to masks.
- Cleaning and sanitizing will continue according to state guidelines and protocols.
- Staff will have bi-weekly access to COVID-19 testing.

**JANUARY 11, 2021** - Welcome back to school and we hope that you and your families have started the new year well. This is an update on the district's learning plan for Fridley Middle School, Fridley High School and Area Learning Center.

As we communicated earlier, updated guidelines in the Minnesota Safe Learning Plan instructed districts to implement a phased in rolling start to bringing elementary students back to learning at school. This phased in approach allows districts to bring back at a time, a limited number of grade levels in grade PreK-6.

Beginning February 1, 2021, **Fridley Middle School students in 5th and 6th grade who selected a hybrid learning model will return to school in a hybrid format.** Students who selected full distance learning will continue to participate in distance learning.

### FEBRUARY 2021

**FRIDLEY MIDDLE SCHOOL 5TH & 6TH GRADE HYBRID STUDENTS RETURN TO HYBRID LEARNING**
  - Fridley Middle School students in Grades 5 and 6 will return to school in the hybrid learning schedule they were in prior to distance learning. All students will participate in distance learning on Wednesday.
  - 5th and 6th grade students who chose full distance learning for Semester 2 will remain in distance learning.
  - Students in Grades 7 and 8 will remain in distance learning.

**Fridley High School and Area Learning Center students will remain in full distance learning.**

The district's goal is to return all its students back to school as soon as guidelines allow us to safely do so. The district continues to evaluate the spread of COVID-19, availability of vaccines, and work closely with local health officials to determine when we can safely bring back our students in grades 7-12 back to learning at school.

**JANUARY 4, 2021** - We hope you had a great winter break, and we welcome back all our students and families. As was promised before the break, we have an important update to share with you about our plan to return our preschool and elementary students back to in-person learning.

Fridley Public Schools is following guidelines in the state's recently updated [Minnesota Safe Learning Plan](#) and will implement a 'rolling start' approach to return our youngest students to school. This phased in approach will begin at the **start of Semester 2 on February 1**. All preschool and elementary students will remain in full distance learning through the end of January.

We also want to remind you that the district asked families to select a learning model for their children for Semester 2. Preschool and elementary school students who selected full-time distance learning will remain in their preferred learning model during Semester 2.

\* Preschool/Kindergarten/Grade 1 students return to school in person four days a week on Monday, Tuesday, Thursday, and Friday. All students will participate in distance learning on Wednesday.  
\* Preschool students will return to half day school schedule in person on the days listed above.  
\* Students in Preschool/Kindergarten/Grade 1 who chose full distance learning for Semester 2 will remain in distance learning.
- **GRADE 2-4**  
\* Grades 2-4 students in grades 2-4 will remain in distance learning through Friday, February 12.
- **February 15:** Presidents' Day – **NO SCHOOL for all students and staff**
- **February 16:**  
**ALL PRESCHOOL, KINDERGARTEN, & GRADE 1-4 ELEMENTARY STUDENTS**  
\* Students in Preschool/Kindergarten/Grades 1-4 return to learning at school in person five days a week.  
\* Students in Preschool-Grade 4 who chose full distance learning for Semester 2 will remain in distance learning.

*\*The district will communicate with families of secondary school students later this week on plans to return secondary students to learning at school.*





## SUPERINTENDENT MESSAGE

To our Fridley Families:

**AUGUST 3, 2020** - We hope that all our families and students are enjoying the warm summer weather and staying safe. This is a time when districts are preparing for a new school year and are looking forward to welcoming students and families back to school. While our reopening will not look the same as it has been in the past, we are planning on welcoming students back to school in the fall. The COVID-19 virus is still present in our communities, so the decision on how to reopen schools has rightfully raised questions, and even caused anxiety.



The state guidelines on reopening schools allows school districts to make decisions based on the prevalence of the illness in their counties, as well as other factors. Just like each student and family is unique, each school district and county is also unique, and the spread of the COVID-19 virus affects communities differently. While it is not the decision we expected, we understand the need to allow school districts to customize their reopening plans according to the available data on the spread of COVID-19 in their local counties.

Reopening schools during a pandemic presents a lot of challenges and, in the past several weeks, the district and school leadership teams have spent significant time planning on a reopening model that will maximize learning opportunities for students while keeping students and staff safe. We are committed to providing a high-quality education to our students, regardless of the delivery model. Our focus throughout this process is doing so in a manner that prioritizes safety. We surveyed our parents/guardians and staff, collaborated with our buildings and departments, and included our labor union representatives to ensure all voices were represented.

We know the spread of a virus is unpredictable and things can change rapidly. While we plan to reopen schools with a hybrid model and full distance learning option for students, we know we will need to be flexible to accommodate change when necessary. We will do our part as a district to follow recommended guidelines to help slow down the spread of the COVID-19 virus in our school community.

This planning document will give you more information on our learning models, how we are going to maintain safety while educating our students, and providing services such as meals, transportation, and childcare. The district and schools will be communicating with you regularly in the coming weeks as we near the start of the school year.

We are in this together, and we will get through this together.

Fridley Public Schools follows guidelines issued from the Minnesota Department of Education (MDE) and the Minnesota Department of Health (MDH) to determine how to safely reopen schools.

**STAY SAFE MN**

The decision on which models to implement are based on Anoka County data on the spread of COVID-19 virus and:

- Prioritized the safety of students and staff.
- Prioritized in-person learning, especially for young learners.
- Considered the infectiousness and transmission risk among different ages.
- Supported the planning, while permitting flexibility for districts.
- Took into account the prevalence of COVID-19 in our county.

Along with reopening guidelines, MDE is also requiring districts to look at the spread of the virus in the school district's county of residence and, based on that data, determine the best option of reopening that will maximize safety for students, staff and the community.

## **LEARNING MODELS BASED ON CALCULATED SPREAD OF COVID-19**

MDE has established the following ranges to determine learning models based on the number of COVID-19 cases per 10,000 over a 14-day period:

- 0-9 cases: In-person learning for all students.
- 10-19 cases: In-person learning for elementary students; hybrid learning for secondary (middle and high school) students.
- 20-29 cases: Hybrid learning for all students.
- 30-49 cases: Hybrid learning for elementary students; distance learning for secondary (middle and high school) students.
- 50 or more cases: Distance learning for all students.

According to MDE guidelines and other factors, this means that Fridley Public Schools will start the school year in hybrid learning for K-12 students and will provide distance learning as an option for families who prefer that learning model for their children.





School districts will base their models throughout the year (unless otherwise directed by MDE or the Governor’s office) on this data, along with consideration of several factors impacting school or district capacity to fully implement a particular learning model for students and staff.

The infection rate and spread of COVID-19 may change frequently in the coming weeks and months. We will continue to monitor the data and adjust our learning models as needed, especially if our school district is not able to maintain staffing. This means, even if our cases fluctuate up or down, we may need to implement distance learning for all K-12 students due to other factors.



## **IMPORTANT REMINDER**

If the COVID-19 pandemic were to change in a significant way between now and the start of the 2020-21 school year, we may need to shift models per the guidelines provided by MDE and MDH.



## **What returning to school will look like for students and staff**

### **AT A GLANCE**

#### **Returning to School**

Students and staff will return to school with increased health and safety measures in order to combat the spread of COVID-19 in our schools. District leadership has received input from its stakeholders and will follow health and safety recommendations and guidelines from MDE and MDH on a reopening model that prioritizes safety of students and staff.

#### **Face Coverings**

Per Governor Walz’s executive order, all students and staff will be required to wear a face mask (where exemptions do not apply) while in district buildings. Students will also be required to wear face masks in district transportation vehicles. Visitors will also be required to wear a face mask.




## Social Distancing

Students will practice social distancing from their arrival at school through departure to limit exposure. Grab-and-go breakfasts will be available and where possible, eaten in classrooms in order to deter students from congregating in the lunchroom. Staggered release schedules may be utilized in an effort to decrease crowding.

## Classroom Modifications

Student desks will be spaced six feet apart at all times. Extraneous furniture will be removed from each classroom as much as possible for proper social distancing practices.



## Meal Service

Students will receive breakfast in a grab-and-go style in the morning and will be asked to eat in their classrooms. Lunch will include pre-packaged items that can be picked up quickly to reduce time waiting in line. Lunch arrival and dismissal times will be staggered.

## Mass Gatherings

For the safety of staff and students, large gatherings will not be permitted until further notice.

## Extracurricular Activities and Athletics

Our district will follow guidance from the Minnesota State High School League (MSHSL) to make a determination on sports and activities. Currently, athletes are taking part in outdoor and indoor workouts in smaller groups and are following social distance and face mask requirements.

## Before and After School Programs

Student-to-staff ratios will be reduced to encourage social distancing. Students will be assigned to small, separate groups with staggered outdoor activity time.





## *How we will maintain a safe environment for students and staff*

### FACE MASKS/COVERINGS

In compliance with Governor Walz’s Executive Order 20-81, Fridley Public Schools requires all students, staff and visitors to wear a mask while inside our buildings and transportation vehicles. We suggest that parents have masks that their students can bring with them and wear at school. In addition, the State of Minnesota will provide the following supplies to all public schools:

- Every K-12 student will receive one cloth face covering.
- Every K-12 staff member will receive one cloth face covering.
- Every K-12 school will receive face shields for all licensed teachers and 50% of non-licensed staff.



### SOCIAL DISTANCING

- Reconfiguring or moving work spaces to comply with current guidelines
- Reconfiguring or moving teaching spaces to comply with current guidelines
- 6 foot separation stickers in high traffic areas to comply with current guidelines
- Directional signage on the floor to keep student traffic flowing in one direction
- Staggered use of shared and communal spaces
- Increased cleaning protocols in shared and communal spaces



### INCREASED SANITATION STATIONS

- Increased number of areas throughout each building with hand sanitizers for students and staff



## DRINKING WATER

- Bottle filling only. Students and staff are encouraged to bring their own water bottles.

## SAFETY SIGNAGE

- Recommended hand washing hygiene
- Recommended physical distancing
- Awareness of symptoms of COVID-19 virus

## CLEANING AND DISINFECTING

- Increased daily and weekly cleaning and disinfecting protocols

## SHARED OBJECTS

- Individual supplies where possible
- Sanitization requirements after use

## HAND HYGIENE

- Teach and reinforce
- Strategic signage placement



## MODIFIED BUILDING LAYOUTS

- Adjusted student pedestrian patterns
- Creative use of classroom locations within buildings to provide distancing

## Addressing presumed and confirmed exposure to COVID-19

In the event a student or staff member tests positive for COVID-19, our District Nurse and COVID-19 Coordinator Linda Snyder, works immediately with the Minnesota Department of Health and Anoka County to take the appropriate steps. Information is gathered for close contacts, and a very structured process is followed in collaboration with the Minnesota Department of Health.

## Fridley School District follows guidelines issued by the Minnesota Department of Health

- The name and contact information for any known staff member or student who is testing or has tested positive for COVID is referred to Linda Snyder, the District Nurse and COVID Coordinator in the District Health Office.
- The District Health Office gathers information to share with the MDH follow-up team.
- MDH evaluates next steps and provides guidance. If notifications are necessary, the district will use MDH templates to notify parents and staff.
- Fridley School District will follow MDH guidance and notify all identified close contacts of their exposure to a confirmed case of COVID-19, while maintaining confidentiality in accordance with state and federal law.
- The MDH notification template includes a fact sheet that the school district will provide to all close contacts. The letter and fact sheet share instructions for close contacts, including what they need to do to prevent the spread of COVID-19.
- If notifications were to occur, MDH contact tracers make outgoing calls to check on symptoms and to give further guidance to any person with a positive test.
  - A trained worker calls the people who test positive for COVID-19 to ask about their symptoms, how they may have been infected, and who they may have infected.
  - A trained worker calls the people who spent time close to the person with COVID-19.

### MDH may recommend:

Below is a list of examples of possible recommendations from MDH. This list does not include all possible recommendations from MDH. Recommendations depend on the extent of the exposure and what mitigation measures were in place at the time of exposure.

- Based on the details provided during the case investigation, MDH may recommend:
  - Exclusion of close contacts, which involves requiring close contacts to stay home for 14 days.
  - Closing an entire classroom, school, or child-care setting for 14 days (e.g., an in-home child care where children and staff are consistently in close contact). This will depend on the extent of exposure and whether there is the possibility of ongoing transmission in that setting. Any decision to close should be made in consultation with the MDH follow-up team.
- Take no further action if there is no infection.



Following MDE and MDH guidelines, Fridley Public Schools has increased its sanitation protocol. These include:

- Classrooms cleaned and fog sanitized each night
- High contact areas sanitized during the day and each night
- In addition to cleaning, sanitizing spray bottles and rags will be available for staff to wipe down desks and high contact areas in their teaching areas
- Restrooms wiped down and sanitized during the day, deep-cleaned each night
- All hard surface floors scrubbed with sanitizer daily
- Offices cleaned and sanitized each night
- Lunchroom tables cleaned and sanitized after each student has finished eating
- All buildings will be deep-cleaned on Wednesdays



## MSHSL Fall Sport Activities Update

- The MSHSL activities are guided by the spread of COVID-19 in each participating county and the learning models implemented by districts.
- For example, any school with a mandated distance learning model is limited to distance learning training/season.
- Fall activities weeks are reduced by 20%.
- Fall activities competitions are reduced by 30%.
- Competitions will be limited to 1-2 per week.
- Whether defined by school, conference or district, local travel will be emphasized.
- Bus and spectator guidelines will be based on recommendations and guidelines from Minnesota Department of Health.
- The district Activities Department will communicate updates and changes regarding fall activities to families.





## *Maintaining safety while serving meals to students*

School meals will be available for pick up for students who are learning at home, both in the distance or hybrid learning models.

**Please remember:** Student meal accounts will be charged based on their status of Educational Benefits (free, reduced, or paid status).

## **HYBRID MODEL**

### **SCHOOL MEALS DURING IN-PERSON LEARNING**

*(Meals On-Site)*

- Breakfast and lunch will be available for on-site students
- Students will come to the kitchen to get their meals following social distancing protocols
- Students will be eating in the cafeterias or other large spaces while maintaining social distancing requirements
- Meals will be pre-packaged or a grab-and-go option
- Physical distancing will be used in the kitchens and cafeterias
- Nutritional Services staff will be wearing facial coverings
- Students will wash their hands before and after meals
- Limited use of high touch areas, including key pads

### **SCHOOL MEALS DURING HYBRID LEARNING AT HOME**

- Multiple days of pre-packaged meals will be available for students, and delivery/pick up methods will be communicated to families as soon as determined
- Meals will be packaged for 3 days' worth of breakfast and lunch for hybrid learning

## **DISTANCE LEARNING MODEL**

### **SCHOOL MEALS FOR STUDENTS WHO ARE DISTANCE LEARNING ONLY**

- Multiple days of pre-packaged meals, including school-made student favorites, will be available for students/families at designated times and locations
- Meals will be packaged for 5 days' worth of breakfast and lunch for distance learning
- Delivery/pick up methods will be communicated to families as soon as determined





## *Maintaining safety while transporting students to and from school*

Fridley Public Schools will ensure that our bus drivers are taking every precaution to maintain safety and will follow guidelines and recommendations from MDE and MDH.

### STUDENT CAPACITY ON OUR BUSES

- We will use MDE/MDH guidelines to determine the number of students per bus.
- Students from the same household may need to sit together.
- Students may need to sit at windows to provide additional separation.
- Students will load the bus using seats in the back first and unload the bus from front to back.
- **Students with disabilities:** Individualized Educational Plan (IEP) or 504 plan-driven accommodations will be reconfigured to meet physical distancing guidance while meeting the needs of individual students.



### DROP OFF/PICK UP ZONES

- The district may need to modify bus and parent drop-off and pick-up zones and loading/unloading times to accommodate a potential increase in self-transported students.

### KEEPING OUR BUSES SAFE

- Buses will be disinfected following each route with special attention to high touch areas.
- Additional ventilation may be provided from partially opening windows and/or roof hatches as conditions permit.
- Safety signage may be added to promote physical distancing based on MDE/MDH bus capacity limits.

### FACE COVERINGS

- The state requires face coverings for bus riders, including students in Kindergarten through grade 12. While not required, face coverings are recommending for preschool students.
- Bus companies will provide face coverings for their employees.





## **Childcare is available in the hybrid model for children of essential workers in grades K-7.**

Governor Walz's Executive Orders 20-48 and 20-82 define Tier I essential workers to include:

- Healthcare and public health
- Law enforcement, public safety and first responders
- Food and agriculture
- Judicial Branch (essential services)
- National Guard (activated under a Governor Executive Order)
- Educators and school staff providing in-person instruction or caring for children of critical workers
- Childcare and school-age care providers

## FRIDLEY LEARNING MODELS: *Hybrid and E-Learning*

Due to the spread of COVID-19 in Anoka County and the data provided by MDE on the county's infection rate, Fridley Public School students will return to school in a hybrid model (some in classroom instruction and some e-learning) and full e-learning for students whose parents have selected that option for them.

### OVERVIEW OF LEARNING MODELS

- Students in grades K-12 will attend school in a hybrid model. This means students will attend school in-person two days per week and will participate in e-learning from home the other three days.
- Students participating in the hybrid model will return to school at 50% capacity.
- Half of the students will attend school on Mondays and Tuesdays as part of the **Tiger 1: Stripes** group, and participate in e-learning at home on Wednesdays, Thursdays and Fridays.
- The other half of the students will attend school on Thursdays and Fridays as part of the **Tiger 2: Paws** group, and participate in e-learning at home on Mondays, Tuesdays and Wednesdays.
- All students will participate in e-learning on Wednesdays to allow time for cleaning and sanitizing our classrooms and communal spaces.

*In addition, please note that:*

- The district will use its Infinite Campus information system to determine which students will be placed in Tiger 1 or Tiger 2 group. Keeping families together, bus routing options and overall total number of student are factors that impact student placement decisions.
- Wednesdays will be the district's deep-cleaning day, in which all learning spaces will be thoroughly sanitized.
- All students will receive Chromebooks for E-learning.
- All families have the option of selecting full-time e-learning for their students - **Fridley Online Academy**.



## FRIDLEY FLEX HYBRID MODEL

**Fridley Flex Hybrid** is standards-based, rigorous coursework instruction that is facilitated by the students' primary or subject area teacher, and includes a combination of in-person and e-learning instruction.

All students (K-12) who select the **Fridley Flex Hybrid** model will have:

- Participating in a combination of in person learning and e-learning.
- A similar schedule as a regular school day.

**Tiger 1 - Stripes:** On Monday and Tuesday, students in the Tiger 1 - Stripes group attend school and participate in e-learning Wednesday, Thursday and Friday.

**Tiger 2 - Paws :** Students in the Tiger 2 - Paws group participate in e-learning on Monday, Tuesday and Wednesday and in-person learning Thursday and Friday.

Fridley Public Schools has enhanced its online educational program to provide more rigor for students and to ensure that instruction will mirror what students receive during a regular in-person school day. We are excited to share this great opportunity with families.

### GRADES K-5

Students in grades K-5 will participate in a high-quality rigorous, standards-based elementary program instructed by a grade level teacher.

The content for this **FULL TIME online option** will mirror the content that is used in the **Fridley Flex Hybrid** model, but 100% of the instruction, content delivery and activities will be done online.

### GRADES 6-12

New this year to the Fridley Schools is the **Edgenuity** program. This is a **FULL TIME, rigorous, credit based online experience** for students in grades 6-12. **Edgenuity** is an educational platform that allows students to progress through a full individualized course schedule at their own pace.

Progress is monitored by a licensed Fridley teacher and/or a learning mentor.
