

LEGAL NOTICE
BOLTON LAKES REGIONAL WATER POLLUTION CONTROL AUTHORITY

Bolton Lakes Regional Water Pollution Control Authority, under the authority granted to it in Sections 7-249 to 7-254 of the Connecticut General Statutes, has voted to levy sewer benefit assessments on the properties identified by street address and on the maps of the Phase IV Construction Project as more fully described in the report entitled "Preliminary Design Report for Bolton Lakes Sewer Project, Prepared for the Towns of Vernon and Bolton, Connecticut" dated January, 2008 and prepared by Fuss & O'Neill, Inc., as set out below.
