Position Title: **TEACHER, BILINGUAL**

Reports to: Site Principal, District Bilingual Coordinator

SUMMARY:

To help students learn subject matter and skills that will contribute to their development as mature, able, and responsible men and women.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- * Teaches district-approved curriculum.
- * Meets and instructs assigned classes in the locations and at the times designated.
- * Plans a program of study that meets the individual needs, interests, and abilities of the students.
- * Creates a classroom environment that is conducive to learning and appropriate to the maturity and interests of the students.
- * Encourages students to set and maintain standards of classroom behavior.
- * Guides the learning process toward the achievement of curriculum goals. Establishes clear objectives for all lessons, units, projects and the like to communicate these objectives to students.
- * Diagnoses the learning styles of students.
- * Evaluates pupils' academic and social growth, keeps appropriate records and prepares progress reports.
- * Is available to students and parents for education-related purposes outside the instructional day.
- * Keeps principal informed regarding needs of ESL students.
- * Promotes and coordinates professional growth of assigned staff through personal counseling, participation in study conferences and committees.
- * Attends scheduled bilingual staff teacher meetings.
- * Other duties as assigned.

Supervises classroom and students.

EDUCATION

Bachelor of Arts degree.

CERTIFICATES, LICENSES, REGISTRATIONS:

Valid teaching certificate with bilingual endorsement.

LANGUAGE SKILLS:

Ability to read, analyze, and interpret general business periodicals, professional journals, technical procedures, or governmental regulations. Ability to write reports, business correspondence, and procedure manuals. Ability to effectively present information and respond to questions from groups of managers, clients, customers, and the general public.

MATHEMATICAL SKILLS:

Ability to work with mathematical concepts such as probability and statistical inference, and fundamentals of plan and solid geometry and trigonometry. Ability to apply concepts such as fractions, percentages, ratios, and proportions to practical situations.

REASONING ABILITY:

Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists. Ability to interpret a variety of instructions furnished in written, oral, diagram, or schedule form.

OTHER SKILLS and ABILITIES:

Ability to apply knowledge of current research and theory to instructional program; ability to plan and implement lessons based on division and school objectives and the needs and abilities of students to whom assigned. Ability to establish and maintain effective relationships with students, peers and parents; skill in oral and written communication.

PHYSICAL DEMANDS:

While performing the duties of this job, the employee is frequently required to stand and talk or hear and sometimes walk and sit.
