### **Position Purpose**

Summerside Camps offers waterplay and other special events to enhance the Day Camp program and weekly themes for campers in grades prek- 6. The Waterplay and Special Events Instructor will develop games and programming to create a safe, fun and engaging environment for campers. The Waterplay and Special Events Instructor facilitates activities as established by the Summer Camp Director utilizing learning resources, Summerside Camps supplies and the SCH campus/environment.

#### **Essential Functions**

- At the direction of the Camp Director and/or Assistant Director set up and break down water play materials and special event areas, daily.
- During inclement weather: organize other fun/engaging activities utilizing camp supplies and facilities.
- Support weekly camp themes, as directed, through the creation of group activities and other Special Events
- Communicate supply needs and condition of materials to the Director or Assistant Director.
- Supports the Day Camp Director, Instructors, and Specialty staff with special event activities as assigned.
- Supports rules of conduct and creates a warm and welcoming environment.
- Maintains water play areas, keeping them safe from hazards to ensure Camper safety.
- Attends work and arrives/departs work at the appropriate times as determined by Summerside Leadership.
- Assumes other job-related duties assigned by the immediate supervisor.

#### Qualifications

- Ability to communicate effectively and professionally.
- Strong interpersonal and communication skills and the ability to work effectively with a wide range of constituencies in a diverse community.
- Willingness to be flexible with change in duties.
- Knowledge of content, methods, materials, and equipment for Summer Programs.
- Knowledge of applicable safety procedures.
- Ability to provide a supportive and caring environment for children.
- Comfortable with a team-based work structure; ability to demonstrate flexibility on the job.
- Demonstrates initiative, is conscientious, and provides complete follow-through on areas of responsibility.
- Must be 18 years of age or older.
- At least four years of experience working with children ages 3-10 years; Bachelor's Degree in Early Education preferred.
- •At least one year of summer camp experience
- Aquatics experience and related certification, preferred
