# E) PUBLIC HEARING (7:35 PM)

7:35PM Mayor Daniel A. Champagned called the Public Hearing and Special Town Meeting to order.

Clerk read the Legal Notice.

Mayor Daniel A. Champagne called for nominations for Moderator. Council Member Wakefield, seconded by Council Member Schaefer made a motion to nominate Kristy Vale for Moderator. Motion carried unanimously.

Moderator Kristy Vale explained that the Special Town Meeting will serve as a Public Hearing for comments on the question "A Resolution regarding an additional appropriation for the general government in the amount of \$250.000.00."

#### **Public Comment:**

Council Member Schaefer inquired of Union Street sidewalks and the disrepair of Grove Street sidewalks.

Council Member DiDio spoke in favor of the project, especially from a public safety standpoint.

Council Member Letendre questioned the content of the legal notice.

Council Member Zahner spoke in favor of the project but questioned if this project should be a budget item.

Council Member Motola spoke in favor of the project and commented favorably on the asphalt sidewalks, despite it being a temporary repair.

Council Member Wakefield questioned the start date of the project.

Council Member Bush spoke in favor of the project, for public safety reasons and as a way to encourage healthy walks for families.

Robert Kleinhans, Director of Public Works, along with Mayor Daniel Champagne, spoke and answered questions.

Moderator Kristy Vale closed the public hearing at 7:46PM.

Moderator Kristy Vale explained the voting requirements as follows: to be eligible to vote at this town meeting, any person who is an elector in Vernon and any citizen of the age of eighteen years or more who, jointly or severally is liable to Vernon for taxes assessed against him or her on an assessment of not less than \$1,000.00 as reported on the last completed Grand List of the Town, may vote at this public hearing.

Council Member Wakefield, seconded by Council Member Bush made the following motion as read by Moderator Kristy Vale: MOVE TO AUTHORIZE AN ADDITIONAL APPROPRIATION FOR THE GENERAL GOVERNMENT IN THE AMOUNT OF \$250,000.00 TO COMPLETE THE REPLACEMENT OF FAILED CONCRETE SIDEWALKS ON UNION STREET AND MAPLE STREET. Motion carried unanimously.
