Code of Conduct Relating to After-School Activities March 2021

This Code of Conduct is intended to enable students participating in The Harvey School after-school athletics and arts program and their parents and guardians to acknowledge and accept the personal responsibility involved in taking steps to protect students, staff, families, spectators, and other contacts.

Code of Conduct

In order to reduce my risk of contracting COVID-19, I commit to reading the Health Risk Communication and abiding by all existing guidelines both on and off the field to ensure the safety of my family, teammates, classmates, community, and myself. I commit to reviewing these guidelines and understand that Harvey may provide updates as additional information becomes available. It is my responsibility to stay apprised of these changes to protect myself and others.

As a voluntary participant in The Harvey School after-school program, I pledge to:

___ **(initial)** participate in daily assessments and self-assessments of COVID-19 exposure and symptoms;

___ **(initial)** follow all health and safety guidelines, including, social distancing and the wearing of approved face coverings;

___ **(initial)** not participate in social gatherings, parties, or other activities which are known to increase the potential spread of COVID-19;

___ **(initial)** submit to COVID-19 testing any time it is required, and abide by any and all health department isolation or quarantine orders as I am directed by the school or healthcare providers;

___ **(initial)** not participate in school classes or athletic events or practices if I am feeling ill or if I have any of potentially COVID-19-related symptoms, until cleared to return to practice by a healthcare professional; and

___ **(initial)** immediately advise the school if I test or have ever tested positive for COVID-19.

As a participant in the after-school program, I understand that I have a personal responsibility to take steps to protect those around me, working to limit the spread of COVID-19 and ensure a safe environment for everyone in the school community. I recognize that COVID-19 is a highly contagious virus and that it is possible to develop and contract the COVID-19 disease even if I follow all of the safety recommendations of the school and comply with this pledge. I further understand that even though the school is following the guidelines issued by New York State,

the CDC, and other experts to reduce the spread of infection, a COVID-19-free environment can never be guaranteed. I understand that if I do not honor this Code of Conduct, I would be failing to comply with a legitimate school directive, and pursuant to school and health department policies, I therefore could be subject to the appropriate accountability measures and disciplinary actions. I also understand that I have chosen to participate in a high-risk activity during a pandemic and have therefore knowingly assumed the risk of contracting COVID-19.
