District officials present updates to COVID-19 responses Quarantines drop from dashboard; dances, other activities possible

hanges on the state level mean changes at the district level in dealing with COVID-19. Assistant Superintendent John Zurbuchen told Board of Education members Tuesday that one of the changes means quarantine numbers are no longer part of the Davis School District COVID-19 dashboard.

The state school manual no longer requires a student or employee to quarantine if they had contact with an infected individual and both people were wearing masks. Zurbuchen says that change means a significantly lower quarantine number. Removing the report from the dashboard helps free up time spent by the Davis County Health Department in compiling the numbers. Also, students who participate in sports and co-curricular activities and test positive in Test to Play screenings will not count against a school's positive cases, he said. However, that number will still appear on the dashboard published on the district's website.

Additionally, Zurbuchen said the state health order redefines Test to Stay. If a school meets the positive case

threshold of 15 for enrollments under 1,500 or 1 percent of the school population, the school must go into soft closure unless it conducts a test to stay scenario. School will remain in session if a minimum of 60 percent are tested in the Test to Stay screening or virus positivity is below 2.5 percent for those tested. If one of those threshholds is reached, only those who test positive would not be allowed to return to school and would quarantine. Those who test negative and those who choose not to participate in the test will be allowed to return to school the next day.

Moving into the spring, Zurbuchen said the district is looking at the options available for field days, elementary performances, dances and graduation ceremonies.

Updates to the school manual do allow a testing scenario for one-time events like dances or graduation, he

Board adopts state resolution to denounce racism

he Board of Education unanimously adopted the Utah State Board of Education resolution denouncing racism and embracing equity in Utah schools.

Board President John Robison said the resolution was sent to all school districts with a request for consideration.

Board member Liz Mumford offered her strong support for creating a school environment that is equitable. In considering the resolution, she said she thought of one of her own family mottos: "When you know better, do better."

"I think we are going to keep

doing better in Davis School District. We are committed to that," she said. "I think all students will benefit because of this effort. One thing I wanted to emphasize is this resolution is not about implementing a curriculum.

swayable opportunities to our kids."

Students would be tested at least 48 hours before the event. Those who test positive could not participate in the event.

For something like graduation, Zurbuchen said the district hopes to establish a way for students to have an in-person graduation experience with an option to participate virtually as well through a livestream. The district will put together a few scenarios that will take into consideration venue limitations and whether a large number of students can be tested in a short period of time.
