Dear Parent(s)/Guardian(s):

The Elementary and Secondary Education Act (ESEA) of 1965 requires that parents or guardians who have children attending a Title I school be notified of how well their school is preparing its students for college and/or a career, as well as the school's designation status under Georgia's ESEA Flexibility Waiver.

Also, under current guidelines outlined in Georgia state law (H.B. 251), school districts are required to provide notice to all parents of their rights concerning school choice options. This letter is intended to satisfy that requirement and offers interested parties a way to seek clarification if needed. According to HB 251, all Title I schools must notify parents of their Intradistrict Transfer rights, even when there is no Intradistrict Transfer Option available. This is the case for Telfair County Schools under the following circumstance:

- Does not apply to districts with only one school at each level (i.e., one primary school, one elementary school, one middle school, one high school, or one combination school).

In addition, under the 2015 renewal of Georgia's ESEA Flexibility Waiver, certain Title I schools continue to be designated as Reward, Priority, or Focus Schools. The Waiver allows the use of the College and Career Ready Performance Index (CCRPI) as the comprehensive report card for all schools in Georgia, providing a score between 0-100 for each school—measuring how well the school is doing in preparing its students to be successful in college and/or a career. The 2015 CCRPI score for Telfair County High School was 77.3. The 2016 CCRPI scores have not been released by the State at this time.
