

Carden Arbor View School Spring Benefit Raffle Official Rules and Regulations

Carden Arbor View School (CAVS), a tax exempt organization under Section 501(c)(3) of the Internal Revenue Code, is conducting this raffle to raise funds for its General Operating Fund. The Rules and Regulations of the CAVS Spring Benefit raffle are set forth below. By purchasing a raffle ticket the purchaser agrees to be bound by these rules and regulations. Carden Arbor View School's interpretation and application of the rules and regulations shall be final.

The Carden Arbor View School Spring Benefit Raffle will be held on May 15, 2021. Tickets will not be sold after 4 pm on May 13, 2021. Drawings may be available through a media broadcast outlet. The winner does not need to be present to win.

There will be no limit to tickets sold. The chances of winning are based on the total number of tickets sold. The fewer tickets sold, the greater your chances of winning. The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions. Consult your tax advisor.

Prize winners may be liable for fees, local, state and federal taxes. Consult your tax advisor. This offer is void where prohibited by law, and all federal, state and local laws and regulations apply.

By entering this raffle, entrants accept and agree (1) to be bound by all the rules, limitations and restrictions set forth here and (2) that their names and/or likenesses may be disclosed to and used by the news media and may otherwise be used by CAVS for publicity purposes and in lists of prize winners to be published in newsletters and announced on the CAVS raffle website. Other rules and regulations may apply. Please contact CAVS if you have questions. CAVS interpretation and application of the rules and regulations shall be final.

By entering this raffle, each participant releases CAVS, its directors, officers, employees and agents from any and all liability for injuries, losses or damages of any kind caused by participating in the raffle or winning any prize or resulting from acceptance, possession, use or misuse of any prize, and each winner agrees to indemnify and hold CAVS harmless from any and all losses, damages, rights, claims and actions of any kind rising in connection with or as a result of participating in the raffle or the winner's acceptance or use of any prize.

Further, each participant hereby waives the provisions of civil code section 1542 which states the following: "A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."

Certain prize winners may be required to sign a written agreement confirming the above-described release and a waiver as a condition to receiving such prize(s).

Tickets:

Tickets are \$200 each. Only one eligible family may be entered in the raffle per ticket sold. Only one method of payment and one mailing address are permitted per ticket. If the name of more than one person is submitted with a ticket purchase and that ticket is selected as a winning ticket, the person named first will be deemed the holder of record of that ticket and declared the winner.

CAVS reserves the right to reject any entry form that is submitted with payment that does not constitute "good funds." All defective or physically altered entry forms will be immediately disqualified by CAVS. Prior to the drawing, CAVS will make a reasonable effort to notify the individual that submits such an entry form, or one which has been rejected because the credit card or check did not clear, that the entry has been rejected by attempting to make contact through the information provided at the time of submitting the purchase request. All orders for tickets for the drawing must be received and/or purchased by the indicated deadline. Any orders received after these deadlines will be returned.

A raffle participant's sole and exclusive remedy for CAVS breach shall be limited to the return of the purchase price paid for his or her raffle ticket(s). In no event shall CAVS, its directors, officers, employees, agents or representatives be liable to any party for any loss or injuries to earnings, profits or goodwill, or for any incidental, special, punitive or consequential damages of any person or entity whether arising in contract, tort or otherwise, even if advised of the possibility of such damages.

How to Purchase:

Individuals are not limited to the number of tickets purchased. To purchase tickets: use the order form provided and mail it to The Carden Arbor View School Spring Benefit Raffle, 1530 North San Antonio Avenue, Upland, CA 91786. Tickets can also be purchased by calling (909) 982-9919 and providing a name, address, phone number, e-mail address and students name(s) along with your credit card number, credit card security code and expiration date. Tickets cannot be purchased on the raffle website. No gaming machine or device will be employed in connection with the raffle or the sale of raffle tickets. All entries must include payment by cash, check or credit card. CAVS reserves the right to reject any entry form that is submitted with payment that does not constitute "good funds." No refunds will be made except under the following circumstances: any ticket order with payment received after May 13, 2021 will be returned. No other refunds are available except at the exclusive discretion of CAVS. CAVS assumes no responsibility for lost, late, misdirected or non-delivered mail or any other failure to receive orders or deliver receipts prior to the drawing deadlines.

Selection of Winners:

The Carden Arbor View School Spring Benefit Raffle will be held on May 15, 2021 from all eligible raffle tickets. The drawings may be available through a media broadcast outlet. The drawing will take place at a CAVS property and tickets will be drawn by the Cougar. Winners will be notified according to the contact information provided to CAVS at the time of ticket purchase. In addition to the list of winners posted on the CAVS raffle website, a list of winners may be obtained from CAVS by calling (909) 982-9919 or sending self-addressed, stamped

In order to collect his or her prize, a ticket winner may be asked to present proof of identity to establish that claimant is the same person who purchased the winning raffle ticket, and prove that the winner is 18 years of age or older.

Winning Odds:

The odds of winning a prize will depend on the number of tickets sold. If 100 tickets are sold the odds of winning the 1st Prize is 1 in 100 and the odds of winning any prize is 1 in 33. If fewer tickets are sold, the chance of winning the 1st Prize, and all other prizes improves.

Eligibility:

Any family and extended family member that is over 18 years of age or older and is related to a currently enrolled student(s) at Carden Arbor View School may purchase tickets. Parents, siblings, grandparents, aunts, uncles are eligible.

Faculty and staff that are over 18 years of age or older and are related to a currently enrolled student(s) at Carden Arbor View School may purchase tickets. Additionally, their family and extended family may purchase tickets. Spouses, siblings, grandparents, aunts, uncles are eligible.

Spring Benefit Committee Members and Carden Arbor View School Board of Trustee Members that are over 18 years or older of age and are related to a currently enrolled student(s) at Carden Arbor View School may purchase tickets. Additionally, their family and extended family may purchase tickets. Spouses, siblings, grandparents, aunts, uncles are eligible.

Persons of any age, without a family member currently enrolled at Carden Arbor View School may not purchase tickets. Said persons are eligible to make a tax-deductible contribution to Carden Arbor View School at <https://cardenarborview.org>.

Prizes:

1st Prize: A voucher for 100% off tuition for One student for the 2021-2022 school year

2nd Prize: A voucher for \$3000 off tuition for One student for the 2021-2022 school year

3rd Prize: A voucher for \$500 off tuition for One student for the 2021-2022 school year

General Terms and Conditions:

Each prize voucher is valid for one student only and cannot be split or shared. The prizes are non-transferable. The purchaser of the winning ticket must redeem the voucher, which will be immediately applied to a student enrolled in the 2021-2022 academic year at Carden Arbor View School.

Tuition denotes the Carden Arbor View School Annual Tuition based on value stated in the enrollment agreement. Prizes are non-negotiable and can only be applied to the 2021-2022

academic year. The winning voucher will be automatically applied to the highest cost at the generation of invoices for the 2021-2022 school year. If the winner has multiple students enrolled at CAVS, the voucher shall be applied to the highest available Annual Tuition in terms of dollar amount. The voucher is valid toward Carden Arbor View School Annual Tuition only. Additional education programs or services are not covered by this voucher, for example, PAUSE, Child Care, International Travel (outside of the outdoor education curriculum), After School Activities (school sponsored and non-school sponsored), unless specified.

If an entrant wins more than one prize and has only one eligible student enrolled, the prize with the highest value will be applied towards the applicable Annual Tuition. If an entrant wins more than one prize and the total winnings do not exceed the Annual Tuition, all prizes will be applied. For example, if an entrant wins 2nd and 3rd prizes and has only one eligible student, all prizes will be applied toward the Annual Tuition for that student.

The prizes have no cash value and cannot be redeemed for cash.

Registration with the State of California:

Carden Arbor View School has registered with the California Department of Justice, Office of the Attorney General as an exempt organization. Registration can be obtained from the Attorney General's website <https://oag.ca.gov/charities>.

Carden Arbor View School is a non-profit corporation under section 501 (c) (3) of the Internal Revenue Code. As a non-profit, all donations of cash and gifts to CAVS are tax deductible to the full extent of the law. Federal Tax ID # 95-3695686 The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions.
