Critical Indicators

- Critical Indicators address the Annual Financial Report and external audit as well as compliance with payment terms.
- Failure to meet any single Critical Indicator results in a FIRST rating of F-Substandard.
- 3. SBISD met all the Critical Indicators.



- Solvency Indicators address a district's ability to meet financial obligations as they come due and continue as a going concern.
- Specified financial ratios and benchmarks are measured.
- 3. Each indicator is scored from 0 to 10.
