Online Auction Governing Rules



GENERAL

Villa Joseph Marie's Auction 2020 will be conducted exclusively online from Tuesday, March 16, at 12:01am through Saturday, March 20, 2021, at 10:00pm. Receipts will be emailed to each bidder. No current high school students are permitted to bid.

BIDDING PROCEDURES

1. Bidding will be done through Greater Giving's Mobile Bidding site at www.vjmhs2021auction.ggo.bid.
2. Bids may be made by selecting the next minimum raise for an item or by setting a maximum bid for that item and allowing the Greater Giving system to bid for you.
3. Bidding categories will be opened for bidding as follows:

4. Each bid must exceed the highest figure on the bid site at any given time.

CHECK OUT PROCEDURES

Payment by the successful bidder must be made through Greater Giving Mobile Bidding, using a credit card, only. Donations to *For the Girls* also may be made at www.vjmhs.org/give/auction or through Venmo (@VillaJosephMarie #0560). All sales are final. There will be no refund or exchange on any items. Please read specifications, limitations, and expirations carefully. If specific requirements are not satisfied, the prize may be forfeited. Neither Villa Joseph Marie nor the donor is responsible for any injuries or damages that may result from the use of a property or service sold.

All resort-private vacation homes are offered to adults and minors accompanied by adults. No pets are allowed.

Items will be distributed from the Villa Joseph Marie campus Tuesday and Wednesday, March 23 and 24, 8:00-11:00am and 3:00-6:00pm. Bidders will be permitted to select their pickup time through SignUp Genius, which

will be made available online on Sunday, March 21. On their selected pickup date and time, winning bidders should proceed to Regina Hall on the Villa campus and should join the pickup queue. We request that you arrive for the queue no earlier than 5 minutes ahead of your scheduled time. If you arrive earlier than 5 minutes from your scheduled time, feel free to park in the school lot between the soccer field and school building. While on the campus, bidders are required to remain in their vehicles, at all times. Auction volunteers will load the appropriate items into bidders' vehicles, after which bidders are asked to exit the campus.

TAX INFORMATION

1. Charitable organizations are required to provide contributors with detailed tax information in connection with their charitable contributions, including amounts paid for items offered at Auction. Villa Joseph Marie will comply with applicable laws, but the donor must be aware of the rules and follow them closely.
2. Charitable deduction for the purchase of items is limited to the amount, if any, by which payment exceeds the fair market value of that item. This is true even if the item was donated to Villa Joseph Marie for the Auction.
3. Your receipt includes a good-faith estimate of the value of the item offered. We have done our best to make a good-faith estimate of the value of each item in the Auction, however, we are not professional appraisers and are not responsible for the accuracy of such valuations.
4. If your winning bid is more than \$250, you will require a receipt to substantiate any deduction you are otherwise entitled to claim. You will be provided a receipt listing all items and the fair market value for those items. Please remember to retain your receipt for income tax purposes. The IRS may disallow deductions for which you cannot produce a receipt when asked to do so.
5. As a donor of an Auction item, you must retain your copy of the Auction contract and/or acknowledgement in or to claim a tax deduction.
6. It is advisable to consult your tax advisor for definitive advice regarding the deductibility of an individual item.

Virtual Bidding

REGISTER TO BID

1. Click on the bidding link.
2. Browse items.
3. Click on "Get Started" to create your Virtual Bidding Account. If you have registered in the past for the Villa Annual Pre-Auction or Auction, then simply sign-in to your account.
4. Follow the easy step-by-step instructions.
5. A credit card is needed, so please have one ready. Your account will be charged only if you have a winning bid at 10:00 p.m. on Saturday, March 20, 2021.
6. Happy bidding! Please remember to bid often and bid high to support our Jems.

BIDDING – USING YOUR SMARTPHONE

1. Once logged in, your name will be displayed on the home screen. Click on "Start Bidding."
2. Use **Magnifying Glass** to search for auction packages by number or keyword.
3. Use Drop Down menu to search as follows:
 - ◇ **Favorites**
 - ◇ **Bids**
 - ◇ **Act Now** menu to search for items:
 - ◆ No Bids
 - ◆ Opening Soon
 - ◆ Buy Now
 - ◆ Multisale
 - ◇ **Categories**
4. Click the **House** to go back to your home screen
5. Tap a package to place a type of bid:
 - ◇ **Bid** – Place a single bid at the next increment.
 - ◇ **Bid More** - Use the wheel to set your bid. The system will bid in your favor until you are outbid or the auction closes.
 - ◇ **Buy Now** – Purchase the package!
 - ◇ Not ready to bid yet? Use the **Star** to save Packages for later viewing.
6. If you are outbid, you will be notified via text message or email. You also will see a notification on your home screen.



FOR THE GIRLS

1. To make a donation, select "For the Girls" near the top of the bidding page.
2. Choose a preset amount or select the **Custom Amount** button. Please remember that no donation is too great or too small.

AFTER THE AUCTION CLOSES






