

School Facility Information




Perry G. Keithley opened in 1961. Additional space was added in 1967 and we became a middle school in 1985. We are named for Perry G. Keithley, Jr. who served as a principal and superintendent in our district. The school was completely remodeled during the summer of 1999. Our building facility is used by the community, Franklin Pierce Schools, and parent groups for meetings and activities. Keithley's fields are also


used by many sport teams including the Summit Parkland Youth Association and Pierce County Parks. Approximately two hundred dates a year are reserved for use of our facility by various groups for a variety of activities. Keithley Commons is the third newest building in the district. The new building serves as the central kitchen for all Franklin Pierce elementary schools as well as feeding Keithley students. The Commons' performing arts stage, band room, and multipurpose computer lab are a showcase for the District.


Parent and Community Feedback Summary

Annual parent and community feedback surveys were not administered for the 2019-2020 school year due to COVID-19. In lieu of that information results from the 2018-2019 school year are provided below.

Survey Results: Students, parents/guardians, and staff all complete perception surveys asking about (1) Student-Led Conferencing and (2) School Climate and Safety in the fall and spring each year. The data is reviewed by the Building Leadership Team (BLT) for data-based decision making. Spring of 2018 was the first time staff (n=38) were asked the same climate/safety questions as students (n=431) and parents/guardians (n=372). The 2018 fall results for staff (n=45) were included to show changes.

Plans for Learning Improvement

The 2020 school year brought many challenges as students attended remote classes for much of the year. One way that PGK addressed these challenges was by developing Team Engage. PGK's Team Engage includes the administrators, counselors, social workers, security, attendance, and behavior support paraeducators. We meet weekly to identify and support students and families with attendance, remote learning, and other challenges that come up.

Team Engage supports families by:

- Providing a food, clothing, and hygiene products closet. Families can complete an online request form to request specific items. These can be picked up or delivered.
- Weekly food bag deliveries to families with food insecurities.
- In class support for students who are struggling. When requested, Team Engage member shows up and helps student.
- Contact students who have not logged into their online classes by phone, or if that is unsuccessful, make a home visit.
- Home visits for technical support, supplies or materials drop offs.
- Weekly lunch get-togethers and social-emotional learning classes for students wanting more connection time.




