



FUHSD Parent/Guardian Health and Safety Agreement for In-Person Activities and Instruction

FUHSD is pleased to be able to reopen our schools for activities, athletics and instruction. The health and safety of our staff and students is our number one priority. In order to mitigate an increase in exposure to COVID-19, the following agreements must be followed. Before your child is eligible to participate in on-campus activities and/or attend classes in-person, the following health and safety agreement needs to be reviewed with students and signed by parents/guardians.

Health and Safety Agreements

Parents/guardians and students agree to adhere to the following health and safety measures:

1. Students and parent/guardian will conduct daily COVID screenings to assess students for any COVID related symptoms prior to arriving at campus. These symptoms include, but are not limited to: shortness of breath or difficulty breathing, fever (temperature 100.4 F or greater) or chills, cough, recent loss of taste or smell, sore throat, muscle or body aches, unexplained headache, unusual fatigue, nausea or vomiting or diarrhea. Students will receive a daily email from Qualtrics in order to facilitate the daily COVID assessment. Students are expected to complete this daily assessment prior to attending in-person.
2. Any student who develops known COVID-19 symptoms during the day will be moved to an isolation area. Parents/guardians will be contacted and the student must be picked up or released from the campus immediately.
3. Prior to returning in-person from having symptoms associated with COVID-19, the student will need a doctor's note clearing them to return or a negative COVID-19 test result. A valid doctor's note must include the following three pieces of information:
 1. confirmation that a medical evaluation was completed by the doctor (a tele-health appointment is valid);
 2. a statement that an alternative explanation for symptoms has been identified; and
 3. a statement that COVID-19 testing is not indicated.

Individuals must be fever-free for 24 hours (without taking fever-reducing medication) and show signs of improvement of their symptoms, before returning to campus.

4. In the event that a student has been exposed to anyone who has tested positive or are presumed positive for COVID-19 in the last two weeks, parent/guardian will not send their student to school. Parent/guardian shall notify the Attendance Technician that the student has been kept home for this reason and understands that the student will not be able to return to school in person until permitted by FUHSD in compliance with direction from the Santa Clara County Department of Public Health.



5. Parent/Guardian understands that the District may direct his/her child(ren) to quarantine if his/her child(ren) has been in close contact with someone suspected of having COVID-19 or isolate if his/her child(ren) have tested positive for COVID-19. If directed to quarantine or isolate, Parent/Guardian understands and agrees to the following:
 - a. Students who are required to quarantine or isolate, but are well enough to participate will be expected to attend class through remote instruction during the period of quarantine or isolation.
 - b. Students who are required to quarantine or isolate may not return to in-person instruction until permitted to do so by the District in compliance with direction from the Santa Clara County Public Health Department and the Santa Clara County Public Health Order.
 - c. If an entire cohort (class) is quarantined, teachers will provide remote learning through synchronous and asynchronous methodologies.
6. Students will wear a mask throughout the school day while the student is on-campus, with the exception of seated eating opportunities during designated breaks. Parents/guardians and students understand that students will be removed from the in-person learning environment should they refuse to wear a mask at any time while on campus.
7. Students will maintain a 6-foot distance between themselves and other students and staff both inside and outside of the classroom space.
8. Students will practice proper COVID hygiene related to hand washing and the frequent use of antibacterial hand sanitizer, which will be available in all classrooms. Wipes will be available in all classrooms should students choose to wipe down their desk and/or other surfaces.
9. Every classroom will be cleaned nightly. For our full cleaning and disinfecting protocols, please visit our [Distance Learning and COVID-19 Resources webpage](#).
10. We are working on having rapid antigen tests available for students and staff who would like to utilize this service.
11. Parent/Guardian understands that due to the current public health emergency, non-essential visitors will not be permitted to be on campus. Only staff, students and essential visitors may access campus. Visitors (including parents) who need to access the school campus will be asked to call the school in advance to discuss needs and schedule an appointment if necessary.

Attendance Agreements

1. Unless a student is experiencing COVID-like symptoms and/or is ill, students who sign up for the in-person learning option need to attend all class periods in-person. Should an in-person learning student decide to attend a class remotely, they will be marked absent in order to facilitate communication with parents/guardians.
2. If a student decides they would like to switch to the remote learning option after the reopening of school, their parent/guardian may contact their school in order to make this adjustment to the student's learning group.



COVID-Related Campus Climate Agreements

Students will be expected to comply with all COVID Health and Safety agreements. Students who fail to wear their mask or adhere to the social distancing requirements will be given one warning. Continued failure to follow the safety requirements will result in the student being sent home for the remainder of the day. This will be an unexcused absence and the parent/guardian will be notified.

We expect all FUHSD community members to collectively safeguard the health and safety of others, and to abide by the policies, procedures and orders related to COVID-19 implemented by the State, County and Fremont Union High School District. As educators, we are committed to keeping our entire school community as safe and healthy as possible by following all protocols and procedures outlined in this health and safety agreement. Thank you for your support and continued partnership.
