Continuous Learning and Accommodations







The Indiana Department of Education (IDOE) is dedicated to serving schools and families as they navigate the unprecedented educational landscape created by the COVID-19 pandemic.

The IDOE has chosen to use the language "Continuous Learning" as opposed to "eLearning", "distance learning" or "virtual learning" to help school leaders think holistically and progressively about how to best meet the needs of all learners. Access and equity must be considered when developing and implementing continuous learning plans.

When providing remote instruction and learning activities to students with Individual Education Programs (IEP) and Section 504 Plans, it is required to provide accommodations as stated within each student's plan.

The IDOE Office of Special Education, in collaboration with the Indiana IEP Resource Center (IEPRC), has developed a list of daily accommodations that are frequently used by students in the brick and mortar setting and examples of how these accommodations can be applied remotely when implementing continuous learning.

Within this document, accommodations are organized into four categories:

- Presentation—how students receive information,
- Responding—how students show what they know,
- Setting—how the environment is made accessible for instruction and assessment, and
- Scheduling—how time demands and schedules may be adjusted.

It is most beneficial to provide familiar supports to students during this time rather than introducing something new. If students have been using support in the classroom, and this can be replicated in the home environment, this is the recommended practice. If not, alternative methods to support student learning must be determined.

Please note that the examples provided do not represent all possible accommodations. Staying regularly connected with students and families is one of the best ways to provide support. Consider connecting with students and parents on a regular basis. Connect virtually or by phone to check-in, provide words of encouragement, offer feedback on assignments and to share the strategies used in the classroom. Frequent communication can help determine if the support provided is sufficient or if additional supports are needed. Finally, the IDOE Office of Special Education and Indiana Resource Network support the accommodations listed below with additional resources, training, and information.

Provide visual content when appropriate Provide closed captioning for all video content Provide interpreter virtually if appropriate Remote American Sign Language (ASL) interpreters or remote speech-to-text professionals included in the platform, which will likely require testing various view options and features to ensure interpreters or real-time captions are easily seen on screen, and that any other accommodations still work properly. For interpreting services, does the platform split the screen view or pin a video in order to permanently keep the interpreter's video feed on screen? For speech-to-text services, does the platform have the ability to connect and sync the real-time captions on screen? If the view is not conducive within the platform, are there other programs or equipment that can be considered for separately casting interpreters or captions? For example, provide an iPad to a student to cast interpreters through FaceTime, Whereby, Skype or other video software. Have you considered your clothing or lighting? Video conferencing etiquette recommends clothing that is not "busy" and provides ample contrast with your skin, and making sure there is enough light in the room that is sufficiently diffused to reduce or eliminate shadows.

Setting Accommodations

Student requires behavioral supports.
