No close contact allowe **Dial at '2'** Enrichment classes and programs are allowed to be inperson following state and District health and safety guidelines for participation. Registered participants only, no observers.

Dial at '3 Enrichment classes and programs are allowed to be in-person following state and District health and safety guidelines for participation. Registered participants only, no observers. **Dial at '4'** Enrichment classes and programs are allowed to be in-person following state and District health and safety guidelines for participation. Registered participants only, no observers. **Dial at '5'** Enrichment classes and programs are allowed to be in-person following state and District health and safety guidelines for participation. Registered participants only, no observers.

Dial at '6' All enrichment classes and programs allowed, no restrictions.

Community Education: Programming providing in person classes and activities to early childhood, youth, or adult students. These programs include the Burnsville Senior Center, and Adults with Disabilities, enrichment classes, fitness and sports for adults. Prekindergarten-grade 12 enrichment classes, fitness and sports. Swimming lessons and Aquatics programs for all ages.

Facilities: Non-District sponsored facility use for all Class A,B,C and D user groups.

FACILITIES

Dial at '0' All District facility and grounds use is suspended for non-District sponsored user groups. This includes long term contracts.

Dial at '1' Limited facility requests. Non-district use priority is given to approved youth sport associations. Individual skills and drills only. Small pods; no contact. Practices only, no competitions, no spectators. User groups using District spaces for meetings will be asked to move to a virtual platform/ non-district space. Long-term facility use contracts permitted with restrictions. **Dial at '2**' Limited facility use and spaces can be requested. Nondistrict use priority is given to approved youth sports associations. Limited competitive drills in small pods is allowed. Practices only, no competition and no spectators. User groups using District spaces for meetings will be asked to move to a virtual platform / non-District space. Long-term facility use contracts permitted with restrictions. **Dial at '3'** Limited facility use and spaces can be requested. Nondistrct use priority given to approved youth sports associations. Full team practices with competitive activity allowed within practice. Intra squad scrimmages allowed. Practices only, no competition and no spectators. User groups using District spaces for meetings are allowed to meet in-person following state and District health and safety guidelines. Long-term facility use contracts permitted with restrictions. Dial at '4' Limited facility use & spaces requests permitted for commonly used spaces. Nondistrict use priority given to approved youth sports associations. Full team practices with competitive activity allowed within practice. Intra squad scrimmages allowed. Competitions allowed; no spectators. User groups using District spaces for meetings may meet in-person following state and District health & safety guidelines. Long-term facility use contracts permitted with restrictions. **Dial at '5'** Limited facility use and spaces can be requested for commonly used spaces. Non-District sponsored use priority will be given to approved local youth sports associations. Competitions allowed but with limited spectators (2 spectators per participant at high schools). No spectators for practices or meetings. User groups using District spaces for meetings are allowed to meet in-person following state and District health and safety guidelines. Long term facility use contracts are able to take place with restrictions.

Dial at '6' Full facility use by non-District sponsored user groups.
