Spring Recess Safety Guidelines

Dear Newmark Parents and Staff,

Just a reminder, with Spring Recess (April 2-9, 2021) coming up, we wanted to share a very important **Spring Recess Safety & Travel Update - [VIEW VIDEO](#)**.

General Reminders:

- Stay vigilant and follow the CDC guidelines
- Notify Newmark at covid@newmarkeducation.com if you and your child plan to travel or have traveled to any state besides NY, PA, CT, DE. If so, your child will need to follow the protocol below to return to school after travel:
 - To return in 7 days after travel:
 - Stay home and self-quarantine for 7 full days
 - Get a PCR test (not Rapid Antigen) 5 days after travel AND
 - Send covid@newmarkeducation.com the results so your child can resume onsite classes.
 - To return in 10 days after travel:
 - Stay home and self-quarantine for 10 full days. No test required.

Notify covid@newmarkeducation.com of your travel plans and on returning to school based on the above information and complete the [Request for Instruction Change Form](#) on the PowerSchool portal.

As always, continue to notify Newmark at covid@newmarkeducation.com if:

- Your child exhibits any symptoms
- Your child has tested positive for COVID-19
- Someone in the household has tested positive for COVID-19
- Your child or someone in the household has been exposed to COVID-19
- If your child or anyone in the household is awaiting test results for COVID-19

If your child has any of the above and needs to quarantine, please complete the [Request for Instruction Change Form](#) available on the PowerSchool Parent Portal so they can participate in LIVE Remote Instruction when school resumes after Spring Recess.

The transmission of the COVID-19 virus has not stopped because of the vaccine. It is important that everyone remain proactive in guarding themselves and their families in the transmission of the virus. Health Officials have asked us to remind parents and staff to continue wearing masks, wash your hands and social distance from others who are not part of your immediate household, whether indoors or outdoors.
