### **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters that we communicated to District management and Board of Directors in a letter dated April 8, 2020, related to Alternative Learning Experience enrollment reporting. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Kennewick School District No. 17 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Basic and alternative learning experience student enrollment reporting
- Use of restricted funds professional learning and Associated Student Body
- Establishment of local revenue and expenditure accounts
- Accounts payable general disbursements and electronic funds transfers
- Procurement public works
- Tracking and monitoring of theft sensitive assets, such as computers
- Payroll gross wages and leave cash outs

### INFORMATION ABOUT THE DISTRICT

Kennewick School District No. 17, located in Benton County, provides educational services to about 19,000 students in pre-kindergarten through 12th grade. The District operates three high schools, an alternative high school, one project based high school, a skills center, five middle schools, 15 elementary schools, a parent partnership, STEM high school and one preschool. In addition, the District also holds classes at the Juvenile Justice Center.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations and about 2,500 employees. For fiscal year 2019 the District's total expenditures were about \$305 million.
