AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Kennewick School District No. 17 from September 1, 2017 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement – public works, cooperative purchases, and professional services
- Compliance with public works projects – change orders
- Self-insurance – unemployment and worker's compensation
- Associated Student Body activities – fundraisers and cash receipting
- Accounts payable – general disbursements and credit cards
- Payroll – gross wages, overtime, leave balances and leave cash outs
- Cash receipting – timeliness and completeness of deposits in the Nutrition Department

INFORMATION ABOUT THE DISTRICT

Kennewick School District No. 17, located in Benton County, provides educational services to approximately 19,000 students in pre-kindergarten through 12th grade. The District encompasses 292 square miles. The District operates three high schools, an alternative high school, one project based high school, a skills center, five middle schools, 15 elementary schools, a parent partnership, STEM high school and one preschool. In addition, the District also holds classes at the Juvenile Justice Center.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 2,200 employees. For fiscal year 2018, the District's total expenditures were approximately \$296 million.
