ECPPS welcomes additional students and staff on campuses as we transition to Plan A on April 12th. Parents/guardians recently had the option to select in-person or remote learning for their child(ren). This handout will provide important information at a glance.

April 12th... All Students Report

What is Plan A?

Plan A allows all students to return to campus for in-person instruction with minimal physical distancing (less than six feet). In-person instruction will take place on Mondays, Tuesdays, Thursdays, and Fridays. Wednesday will be a remote learning day for all students.

ECPPS will follow minimal physical distancing on buses and in classrooms. We will adhere to six feet of distancing as much as possible in all other areas of the facilities and in other settings as well as with adults.

Schools will provide information for parents on meal services, bus routes, and other items of importance as it relates to a specific school.



About Health Screenings

Health screenings are no longer required for students (K-12) to ride the bus or enter the buildings; however, temperature checks will be completed daily prior to entering the school or facilities. Pre-K students will continue to adhere to health screenings per guidelines.

Parents/guardians are asked to conduct home-based symptom screening for students and to keep children home when ill.

The latest list of possible COVID symptoms from the CDC include: fever (temperature of 100.4 degrees Fahrenheit or higher), sore throat, cough (for people with chronic cough due to allergies or asthma, a change in their cough from baseline), difficulty breathing (for people with asthma, a change from their baseline breathing), new loss of taste or smell, diarrhea or vomiting, new onset of severe headache, especially with a fever.

About Face Coverings

Face coverings are required to be worn at all times when on school campuses/transportation (indoor and outdoor) except when actively eating or drinking. Staff will provide specific instructions on when students may remove face coverings and how to safely do so. Exceptions will be made for students in the adaptive curriculum.

WELCOME

- Minimal physical distancing on buses and in classrooms (less than six feet).
- Daily health screenings are not required for students. Temperature checks will still take place.
- Frequent handwashing will be encouraged. Sanitizer will be available throughout the schools.
- Face coverings are required on all campuses at all times.
- Meal services protocols for in-person instruction will be determined by individual schools.
- Meal services will continue for remote students and children in the community - Pick-Ups on Mondays
- Water fountains are not accessible for drinking. Students should bring personal refillable water bottles.
- Playground equipment is now accessible. Students must wash hands/sanitize after recess.

About Transportation

ECPPS will provide bus transportation for students in Plan A. Students are no longer required to complete health screenings/attestation forms prior to riding the bus. Temperatures will be taken at the school upon entry.

Face coverings are required on buses at all times. Minimal physical distancing for students is required.

- Bus routes will be provided to parents by their child's school
- Please contact the student's school for questions related to bus transportation routes.

Visitors to the Schools

To secure the health and safety of school system students and staff during COVID, and in accordance with NCDHHS, non-essential visitors are not allowed access to school buildings at this time.

Any access to a school building by an essential visitor/volunteer will require a health screening and temperature check. This would include parents that may have to access the buildings at any given time.

- Face coverings are required on all campuses at all times.
- All adults entering a school facility will be required to complete a health screening and temp check.

Suspected, Presumptive or Positive Cases of COVID

- Suspected, presumptive, or positive cases of COVID should be reported to school administration as soon as possible.
- If a student or staff member becomes ill while at school, protocols will be in place to isolate the individual until they are able to exit the facility.
- School nurses will work with school administration and the local health department (ARHS) to determine next steps as needed.
