

# Riverside Magnet School at Goodwin University

## RIVERSIDE MAGNET SCHOOL INCOME SURVEY - School Year 21-22

The State of CT subsidizes a portion of preschool tuition for students attending Riverside Magnet School (RMS). In order for us to receive our funding, the Connecticut State Department of Education requires each preschool family to verify their income on an annual basis. Each family needs only indicate if their income falls at or below or above 75% of the state median income.

Also, per CT General Statutes, families of enrolled **preschool students** at RMS, whose gross annual household income is **above** 75% of the state median income, will be required to pay an annual tuition fee. Tuition for preschool students will be determined annually and cannot exceed \$4,053 per child. For our new preschool families, tuition for the SY 2021-2022 is \$4,000 for the first preschool student and \$500 for the first preschool sibling. Our new families will not be charged more than \$4,500 per family for the 2021-2022 school year. Families whose income is **at or below** 75% of the state median income will **not** be required to pay tuition but must still complete this form in order for RMS to be eligible for funding from the State for our qualifying preschool students.

We will NOT grant a waiver to any family that cannot provide supporting income verification and you *will* be responsible for the tuition set forth above and agree to follow the applicable tuition guidelines.
