## Access from AT&T: A Low-Cost Program for Home Internet

### AT&T offers an internet plan for limited-income households

Access from AT&T is a low-cost program for home internet offered to limited-income households who participate in the Supplemental Nutrition Assistance Program (SNAP). AT&T offers internet service for \$10/month, or less based on the maximum speed available at your address. Eligible households will receive free installation and in-home Wi-Fi Gateway with no annual contract and no deposit.\*\*

### Access from AT&T meets connectivity needs

Access from AT&T internet service may suit your connectivity needs for education and homework, job searches and medical resources and keeping up with friends and family virtually.

### How to sign up for Access from AT&T

Check your eligibility for Access from AT&T [here](#). Eligibility is determined by four programs: Supplemental Nutritional Access Program (SNAP), Supplemental Security Income (SSI) for California residents only, Income (temporary) and National School Lunch and Head Start Programs (temporary). Documentation will be required when applying.

\*\* Eligible speed tiers (5Mbps for \$10/mo; or 3Mbps/1.5Mbps/768Kbps for \$5/mo) may be provided depending on availability at your address. Additional Fees & Taxes: AT&T one-time transactional fees, and monthly cost recovery surcharges which are not government-required may apply, as well as taxes. See [www.att.com/fees](http://www.att.com/fees) for details. Service will incl 150GB or 1TB of data allowance per month depending on type & speed of service. You will be charged \$10 for each add'l 50GB of data usage if you exceed your monthly data allowance , even if less than 50 gigabytes is used. ## Income requirements for Access from AT&T

During the COVID-19 crisis, AT&T has temporarily extended eligibility for Access from AT&T to households based on the following income limits.

Household income based on 135% or less than federal poverty guidelines.
