Under the direction of the supervisor of special education, the teacher is responsible for the planning and delivering of Reading, Writing and Math curriculum as specified by the needs of each student in their summer school profile. Teaching responsibilities will include the utilization of researched-based interventions.

- B. Special education certification and experience in the elementary grades
- C. Knowledge and experience in reading, writing and math instruction
- D. Knowledge and experience with behavior management techniques
- E. Training in and experience with administering district assessments such as DIBELS and Delta Math
- F. Training in and experience with delivering district interventions such as Sound Partners, Word Warm-ups, GATE, Comprehension Toolkit, and Multi-tiered System of Support (MTSS)
- G. Demonstrate the ability to use student data to inform instructional practices
- H. Demonstrated ability to differentiate instruction to meet the needs of multiple learners at multiple levels
- I. A demonstrated ability to communicate effectively—orally and in writing
