Stonyhurst Cross-Campus Risk Assessment Overview – 14th April 2021 Addendum to the Roadmap Update of 5th March

Stonyhurst remains totally committed to complying with the latest Government legislation and guidance in relation to the on-going Covid-19 Pandemic. Since the production of the 5th March Stonyhurst Risk Assessment Roadmap Update, new and revised documents have been published by the Government and other relevant bodies. However, whilst we will make best use of the relaxation of some restrictions from the 12th April, there will be limited change to the Stonyhurst Risk Assessment at this point. Where there is change, risk assessments will be undertaken and/or revised. All previous strategies to provide a Covid-secure environment at Stonyhurst will remain in place. The Risk Assessment process is rigorous and on-going. It is reviewed on a regular basis and revised as required.

In planning for the Summer term, we have endeavoured to balance the desire to provide the best possible experience for pupils with the need to proceed with the necessary and required levels of caution. Our absolute priority is the safety and well-being of all members of the Stonyhurst community.

We are delighted to be welcoming back the vast majority of our pupils to school this week. For those pupils who cannot return due to the pandemic, the Stonyhurst Anywhere platform will be available with extensive support for pupils from staff [College - Stonyhurst Anywhere - Stonyhurst](#)

Stonyhurst takes due account of all relevant guidance and incorporates that guidance into its planning and risk assessment processes. The following links may be helpful in providing additional detail about the latest guidance relevant to schools during the pandemic:

The key milestone dates are 12th April, 17th May and the 21st June. At each stage, providing that 4 key tests are met, additional restrictions will be lifted. The tests are:
 - The vaccine deployment programme continues successfully
 - Evidence shows vaccines are sufficiently effective in reducing hospitalisations and deaths in those vaccinated
 - Infection rates do not risk a surge in hospitalisations which would put unsustainable pressure on the NHS
 - The assessment of the risks is not fundamentally changed by new Variants of Concern
- [Further easing of Covid restrictions confirmed for 12 April - GOV.UK \(www.gov.uk\)](#) On the 5th April, the UK Prime Minister announced that the Roadmap for easing Lockdown measures in England was on track. An evidenced-based judgement was that the 4 tests set out by the Prime Minister in February had been met. Therefore from April 12th, some further restrictions could be eased.

In relation to Sport and Games at Stonyhurst, plans for the Summer term will enable pupils to participate in more activities, including, for pupils at Stonyhurst St Mary's Hall, taking part in fixtures with other schools. In making arrangements for sporting activities, Stonyhurst has updated the appropriate departmental and individual activity risk assessments which have been approved by the relevant members of the Executive Team. The school has been mindful of guidance from the individual Sports' Governing Bodies and also the Government Guidance. To facilitate inter-school fixtures the following additional risk mitigation measures have been implemented at SMH:
 - Visiting schools will be asked to arrive changed and to leave in their tracksuits. No on-site changing facilities will be provided. SMH pupils travelling to other schools to do the same
 - Pupils will wear face coverings whilst moving between schools in hired or school transport. Transport arrangements for away games will be risk assessed on a fixture-by-fixture basis to ensure Covid-security is maintained
 - No spectators will be permitted
 - There will be no catering provided and visiting teams/individuals will be asked to bring their own food/drink
 - External visitor transport will be parked in a designated area by the SMH tennis courts, as close to the pitches as possible. No access will be allowed to SMH by any external visitor, staff or pupil
 - Two external portable toilets to be positioned by the cricket pavilion; one male and one female
- [Guidance on shielding and protecting people who are clinically extremely vulnerable from COVID-19 - GOV.UK \(www.gov.uk\)](#). This updated guidance was provided on 1st April when the advice on "Shielding" was amended. As more restrictions are relaxed, Stonyhurst is conscious of its continuing duty of care to staff and pupils who are CEV. The HR team will continue to liaise with the relevant members of staff on an individual basis and the appropriate academic and pastoral staff will work with the parents of pupils in the CEV category. For staff outside the CEV category who can carry out their roles from home effectively, Stonyhurst will continue to support the Government message of "work from home if you can"
- As per previous Risk Assessment Overview documentation, most meetings involving staff will continue to be held virtually. However, from the 12th April, a limited number of smaller meetings may be conducted face-to-face, but only if social distancing can be ensured. If it is deemed essential for a larger group of staff to meet due to a particular circumstance, then only the Stonyhurst Headmaster and/or the SMH Headmaster can convene the meeting and any such meeting will comply with Covid-secure requirements
- [Global Travel Taskforce sets out framework to safely reopen international travel - GOV.UK \(www.gov.uk\)](#) As an international boarding school, Stonyhurst is especially mindful of the restrictions and regulations surrounding international travel. Stonyhurst will continue to keep parents updated in respect of travel and quarantine arrangements. Communication in relation to possible Half Term arrangements for international boarders will be provided in due course directly to parents

Through its Risk Assessment process, Stonyhurst will continue to do everything possible and practicable to provide a Covid-secure environment for all pupils, staff, parents, visitors and all who visit the school campus. Introduction

- Throughout the Covid-19 Pandemic, Stonyhurst has complied with Government legislation and guidance. The school has also been alert to and mindful of guidance from a wide range of other external bodies including NHS, PHE, BSA, HMC, HSE, ISBA and other relevant organisations
- From the start of the Pandemic, Stonyhurst has been committed to making the school and its campus as Covid-secure as possible
- Since September 2020, the school has uploaded key Risk Assessment Overview documents onto its public-facing Website. The RA Overviews have been updated on a regular basis and are supplemented by individual internal departmental risk assessments
- The January and February RA Overview updates on the Stonyhurst Website reflect the Government announcement of a National Lockdown effective from 5th January 2021
- On Monday 22nd February, the Prime Minister provided details of the Government’s Roadmap to exit the current Lockdown. It is summarised in the Government publication accessed via the following link:

- As part of the Government Roadmap, all children in England will start to return to school from the 8th March and Stonyhurst is now preparing to welcome back our pupils. The Stonyhurst Headmaster and the St. Mary’s Hall Headmaster wrote to all parents on the 24th February with initial details and arrangements for returning pupils
- Within the letters, reference was made to Testing regimes and International travel. Heads of Playroom at the College and relevant senior colleagues at St. Mary’s Hall will be available to liaise with families where there are individual queries. Staff and pupils could also be signposted to bereavement counselling provision where appropriate.

Summary of Covid-secure strategy following the Government's Roadmap announcement of the return to school for all pupils on the 8th March 2021

- The on-going Covid-19 pandemic continues to require Stonyhurst to be alert to the need to react and adjust to what can be a rapidly changing Covid-context
- A daily watch is kept on the latest Covid information and data at local, national and international level, including the emergence of new Covid-variants
- Stonyhurst complies with all relevant Government legislation and guidance and takes full account of advice from other relevant national bodies
- The extensive Stonyhurst suite of Risk Assessment documentation is reviewed and revised on a regular basis. The RA Overview Documents, including this Roadmap Update, are provided on the school Website [Covid-19 Information - Stonyhurst](#)
- All processes and procedures have been reviewed in the light of the return to school on the 8th March and where necessary have been revised to enhance Covid-security. Testing, track & trace, bubbles, social distancing, hand hygiene, face-coverings, awareness of the importance of ventilation, enhanced cleaning schedules, revised catering arrangements, amended daily routines, Covid-secure protocols in classrooms, updated school policies, qualified Health Centre staff, availability of an on-site Isolation facility and the on-going reinforcement of key Covid-messaging are all part of the Stonyhurst strategy to keep everyone as safe as possible
- In addition to formal documentation, parents are kept up-to-date via a range of communications from the Headmasters and other senior staff
- At all times Covid-security is of paramount importance and risk assessment and the mitigation of risk are at the very heart of Stonyhurst's Covid strategy
- As pupils, and staff, return after the most turbulent of years, the school will be aware of the need to be especially mindful of the potential for some anxiety and for the need to be aware that each individual will have been on their own Covid-journey
- Whilst returning as far as is currently possible to "normal" school life, pupils and staff will be reminded of the need to comply with the Stonyhurst Covid-guidance and of the need to be fully committed to supporting the school's strategy to keep everyone as Covid-secure as possible


