Reports

Matt McMahon – Distance Learning vs In-Person Learning: took this time to voice his concerns of parents withdrawing their students from in-person learning to distance learning at will. This is hard on the students and staff to continue to learn and teach with non-consistency. He is hopeful that coaches are not encouraging student/athletes to go DL as they are students first. The board and the administration agree with him.

Luann Klevan – Community Ed Director: Things are progressing as well as can be. She focused on budgets for Preschool and Valleyland this evening. Due to COVID19 funding is down. She is looking for board assistance in closing the pay gap between her staff and the K-12 staff as well as increasing tuition. There is also a need to raise Valleyland fees. Mr. Harris asked her to come up with some numbers to present to the Facilities & Finance Committee. A complete copy of her report is attached.

Shane McBroom – Elementary Principal: Parent/Teacher Conferences were once again held by Zoom. The 6th Grade DARE program is going well. PLC Teams are working on goals created to finish the school year. Kindergarten registrations have been or will be soon mailed out. The Kindergarten staff have been brainstorming ideas for a fall Kindergarten Roundup. A complete copy of his report is attached.

Randy Paulson – High School Principal: Explained the Achievement & Integration Budget plan. Congratulated our student athletes and their recent milestone achievements. The HS master schedule will have some adjustments to better meet scheduling needs of both our staff and students. He is also currently looking at increasing our vocational program and special education instruction funding. A complete copy of his report is attached.

Ed Harris - Superintendent: Is grateful to have all the kids back in both buildings 5 days a week. Explained that there is a shortened quarantine recommendation so long as all the protocols are followed. He will meet with the HS Principal hiring committee soon to narrow down the number of applicants for interviews. The board met with Sue Peterson/School Perceptions prior to this meeting to discuss a summer survey regarding a levy renewal. Superintendent Report

<u>Learning Models/COVID 19</u>

The switch to full in person K-12 has gone very well. It is so nice to have all of our kids together!

We did experience a large quarantine of students and 2 coaches at the high school this week. 2 positive cases, 32 quarantines. After much discussion I authorized the use of the abbreviated quarantines as long as protocols are strictly followed. Most schools in the our area use this as well.

2nd doses for staff will be complete by March 12.

High School Principal Search Process

The posting closed last Friday. We have 17 applications on file. Those who wish to be considered for an interview must now submit a 1 minutes video to the selection committee. The committee will meet on March 17 to determine the interview pool. Interviews are scheduled for March 24 and 25.

Community Survey

The School Board will meet remotely with Sue Peterson from School Perceptions at 6:15 pm on March 10 to talk about a summer community survey that will provide information on and gauge the support for an operating levy renewal this coming November. The operating levy that was passed in 2015 is expiring. The revenue from this levy plays a crucial role in the stability of our general budget. Renewing it will not increase taxes.

High School (Grades 9-12) Master Schedule

The Master Schedule for the 2021-22 School year will have a small change. The Blocks A, B, and C will look the same as this year, but the Flex Period and Block D will be combined. For most students they will either have a Flex/Study Time or a class period 8 or period 9. If they have a class period 8 they will have a Flex/Study Time period 9 or if they have a Flex/Study Time period 8 they will have a class period 9. Students wanting both band and choir will have choir period 8 and band period 9 without a Flex/Study Time.

This change will:

Make our scheduling of teachers more efficient

Reduce our large number of students in elective class
Give students more choices of class offering each period
Reduce the number of scheduling conflicts per student
Students will get their first and/or second choice of electives to fit their schedule
This will reduce the total number of electives by one for most of our students

Future Adjustments at the High School

I am going to be looking at a couple of adjustments at the high school that will increase our funding through vocational programs and special education instruction. Currently, we do not have enough FTE to cover both our Social Studies and Economic Finance classes in grades 9-12. This is an area that will need to be resolved prior to us completing the scheduling of students this year for the 2021-22 school year. We also need to look at how we can more efficiently use our special education instruction for both our regular special educational services and our special educational services in our FOCUS ALP program. I will be following up with the board with more specific details.

COMMUNITY EDUCATION BOARD REPORT

PRESCHOOL

- The 4 & 5 Year Old classes returned to the in-person model the week of January 18th.
- The 3 & 4 Year Old classes resumed the week of January 25th.
- Preschool Conferences for 4 & 5 Year Old classes are March 15th & 16th.
- Thank you to the local Masons for their contribution of \$1000 to help cover a scholarship for a new student. ELSA funding has already been depleted.
- Preschool 2021-22 registration for current students began March 8th.
- Preschool 2021-22 registration for new students begins March 15th.
- Based on the recommendation of the CE Advisory Council tuition rates have been increased (see attached).

ECFE

- In-Person parent-child classes begin in April.
- Take-Home project events were successful during distance & hybrid learning.


VALLEYLAND

- Summer registration for current families began March 1st.
- Summer registration for new families will begin April 1st.
- Numbers per classroom for the summer will need to align with the current Covid guidelines.
- Fee structure has been changed for the summer program (see attached)

YOUTH PROGRAMS

- Elementary basketball clinics will begin in April. Thank you to the parents who have stepped forward to coach.
- Efforts are being made to build the After School Enrichment program.
- Summer Rec & Enrichment We are attempting to develop two 4-day camps for the summer (an Arts Camp and an Olympic Training Camp). The camps would meet 8:30-11:30 Monday-Thursday. We are in the process of finding artists, instructors, coaches, etc.

PRESCHOOL



Current:

Revenue - \$217,374

Expense - \$231,594

FY22:

Revenue - \$233,926

Expense - \$233,926

- Based on enrollment of 54 in the 4 & 5 Year Old classes / 28 in the 3 & 4 Year Old classes
- Based on scholarship amounts of \$27,000

Current revenue and expenses reflect the original budget. Due to Covid revenue was lower than expected.

FY22 revenue reflects an 8 percent increase in tuition:

2 mornings - \$95 to \$102

2 Full Days - \$189 to \$204

3 Mornings - \$133 to \$144

3 Full Days - \$267 to \$288

4 Full Days - \$380 to \$410

4 Days Plus - \$460 to \$485

FY 22 expenses reflects a significant increase in staff wages

- Assistants \$1/hour raise to bring them closer to their counterparts I K-12
- Teachers 10 percent raise to bring them closer to the salaries of licensed teachers in K-12

The advisory council recommends that this be considered a 2-year plan. They feel strongly that the assistants continue to receive significant raises to be more aligned with K-12 staff. For teachers, the ultimate goal is to raise salaries to a rate comparable to the CEA salary schedule. This increase would require funding from the general fund.

For future consideration: The advisory council requests that the board consider providing the additional funding needed to raise preschool teacher pay rate to an amount comparable to CEA salary schedule by the fall of 2022.

Justification:

- Licensed preschool teachers have expectations similar to a k-12 teacher.
 - Must create lesson plans based on a curriculum
 - o Assess students at the beginning and end of each school year
 - Monitor student progress throughout the year
 - o Provide support for students who are significantly below target
 - Conference with parents regarding child's growth and readiness for Kindergarten
 - Participate in professional development in order to maintain license
- Chatfield Preschool has a strong program. Our goal is to retain teaching staff. Area schools are
 paying preschool teachers at a higher level. We have already lost one teacher due to better pay
 in a neighboring district.
- Hiring qualified preschool teachers is difficult when the pay level is low.

VALLEYLAND

Change if Fee Structure:

- Summer Valleyland will move from charging on an hourly basis to charging for ½ day and full day. (\$24 for 5 hours or less / \$30 for up to 10 hours / \$35 for more than 10 hours)
 - o Rate is comparable to area schools.
 - Increase in revenue will offset the staff to student ratio required due to Covid.
 (Valleyland may have no more than 14 students & 1 staff per room)
- Registration fee is now \$25 for one child and \$45 for two or more children
