Homeless Prevention

You may qualify to receive temporary help if you are currently homeless or in immediate danger of eviction, foreclosure or homelessness. You will be asked to document a temporary economic crisis and demonstrate an ability to meet the future rental/utility costs after the assistance has been given.

Energy Bill Assistance

The **Illinois Home Weatherization Program** helps households whose incomes are at or below 200% FPL. The type of help provided includes:

- Repairing or replacing windows and doors
- Furnace cleaning, safety checking, repair, or replacement
- Installing smoke detectors, carbon monoxide detectors and fire extinguishers
- Insulating walls and attics
- Sealing cracks with weather-strip and caulk

You may qualify for weatherization services whether you own or your rent your home. If you rent, the owner must agree to repairs.

LIHEAP

(Low Income Housing and Energy Assistance Program) provides help with the cost of winter heating for house-holds with income at or below 150% FPL. LIHEAP provides energy counseling, outreach, education and direct financial assistance once a year.

You are not required to have an overdue bill or a disconnect notice to receive LIHEAP assistance. Emergency assistance is available for eligible households whose utility service has been disconnected and for homeowners whose furnace is not working or determined unsafe.

Benefit Access Program (formerly Illinois Circuit Breaker)

The Illinois Department of Aging Benefit Access Program assists seniors (age 65 and older) and persons with disabilities in obtaining free transit and license plate discounts. You must live in Illinois and meet age and income limits. Once approved, eligibility is good for two years under this program. Phone Assistance Programs



Lifeline provides a discount on monthly telephone service (land line or wireless, not both) purchased from participating providers. **Safe**link provides a wireless phone and monthly

package of set minutes, texts, and data. You may qualify for these programs if you have an income below 135% FPL, or receive benefits through one of the following programs:

- Medicaid
- SNAP (Food stamps)
- Supplemental Security Income (SSI)
- Federal Public Housing Assistance
- Low-Income Home Energy Assistance Program
- National school lunch, free lunch program
- Temporary Assistance to Needy Families (TANF)

There may be other requirements for these programs and you will need to provide proof that you receive assistance through one of the programs listed above. For more information about Lifeline, visit

Marketplace

The Health Insurance Marketplace is a new way to shop for health coverage that fits your budget and needs. After completing one application, you can see all of your options and enroll.

You may use the Marketplace and access financial help to purchase a Qualified Health Plan (QHP) if you are a U.S. citizen or a lawfully present non-citizen who does not have access to health insurance through other means, and if your income falls within the program limits.

With the Marketplace, you can explore the health coverage options available to you, determine which health plan best fits your needs and calculate your eligibility to receive premium tax credits/cost share subsidy which will help to reduce the cost of the coverage.

Medicaid

Medicaid provides health coverage to Illinois residents with low incomes and resources. There are a number of different levels of Medicaid coverage with different eligibility criteria for each. Income guidelines are based on the Federal Poverty Level (FPL).

• Adult age 19-64 who meet income (138% FPL) and citizenship requirements are eligible for the Adult ACA or Family Care Program.

- Children age 18 or younger whose household income meets the requirement (318% FPL) are eligible for the All Kids Program.
- Pregnant women and infants up to one year old that meet income requirements (213% FPL) are eligible for the Moms & Babies program.
- Seniors and persons with disabilities that meet income, resource and citizenship requirements are eligible for the Aid to the Aged, Blind and Disabled Program. Income is limited to



no more than 100% FPL and resources must be at or below \$2,000 for a single person or \$3,000 for a couple. Medicaid Spenddown is available when income or resources are higher than the program limits.

 Former Illinois foster children up to age 26, regardless of their income.

Medicaid Managed Care (Care Coordination)

Once approved for Medicaid, you will need to choose a health plan and a doctor or clinic as your Primary Care Provider if you live in certain regions of Illinois. The goal of managed care is to help you navigate the health care system and to coordinate your care. You will need to get care within your plan's provider network or your care may not be covered by the plan.

Medicare

Medicare is health coverage for seniors age 65 or older and persons with disabilities. Medicare has different parts and different costs.

Illinois Warriors Assistance Program

The Illinois Warriors Assistance Program provides confidential help to veterans who are facing challenges such as Traumatic Brain injury (TBI), Post-Traumatic Stress Disorder (PTSD), and more.

Veterans (VA) Health Care

Federally Qualified or Rural Health Centers

Federally Qualified and Rural Health Centers receive enhanced Medicare and Medicaid funding to provide primary health care to low income persons. Services are usually provided on a sliding scale. Income needs to be verified to determine payment rate. You do not need to be a citizen to get care at these clinics.

Hospital Financial Assistance Programs

Hospitals often have Financial Assistance or Uninsured Discount programs to assist persons who are unable to pay hospital bills.

Pharmaceutical Assistance

If you need emergency assistance with filling a prescription, local organizations, county or township governments may have programs that provide assistance.

Several chain pharmacies, such as Target, WalMart, CVS, Walgreens, and Osco, have a value-priced list of generic medications. Many of the medications only cost \$4.00 for a month's supply. Call your pharmacy to ask if your prescription qualifies.

Illinois Breast and Cervical Cancer Program

Medical coverage is provided for Breast and Cervical Cancer Screenings, or for ongoing cancer treatment. To be eligible women have to be Illinois residents, U.S. citizens or qualified immigrants and uninsured. Even if you have already been diagnosed with cancer, you may receive free or low-cost treatment through this program.
