Parent suggestions:

Involve the parents of both parties in the disputes  
(parents are always contacted)

Require parents to do volunteer service for a day if their child is involved in a fight, as a consequence for the parent.

Require parent and student to do school cleaning assignments as consequences.

They should have to clean the bathrooms.

For uninvolved parents this will not work.

Create an expectation of parental responsibility

Send a letter via certified mail notifying parents of fighting students of their shared accountability/school policy.

Some fights are happening in the public library. Please speak to the public library managers and tell them your concerns.

Item 5: Cell phone use at school is problematic and is contributing to the fighting. (Students are videotaping conflicts and students feel as though they have to fight to avoid losing face. Students are on social media at school recording, participating or inciting fights).

Parents are unhappy that students are using their cell phones at school. They do not need them since they have the school office to make calls during the day. Students should be required to leave their phones at home, and if safety on the way home is an issue, they may leave their phones in the school office until the end of the school day and then collect them. Perhaps we should reward students who do not use their phones in class, for say a week, with a treat of some kind?
