1. Subsequent to the Adoption of the Fiscal Year 2021-2022 Budget at the Town Meeting, the following motions are needed pursuant to Town Charter, Chapter XII, Section 6, "within five (5) days of adoption of the annual budget by the annual town meeting, the Town Council shall fix the tax rate in mils which shall be levied on the taxable property in the town for the ensuing fiscal year."

PROPOSED MOTION:

THE TOWN COUNCIL HEREBY SETS THE TAX RATE FOR THE FISCAL YEAR JULY 1, 2021 THROUGH JUNE 30, 2022, AT **39.63 MILS** UPON TAXABLE REAL AND PERSONAL PROPERTY IN THE TOWN OF VERNON.

IN ACCORDANCE WITH STATE OF CONNECTICUT PUBLIC ACT 16-3, SECTION 187, REFERENCING THE ASSESSMENT YEAR COMMENCING OCTOBER 1, 2020, THE MIL RATE ON THE MOTOR VEHICLE TAX IS CAPPED AND SET AT **39.63 MILS**, AND FURTHER, THAT THE TOWN COUNCIL SIGNS THE TAX WARRANT FOR SAID FISCAL YEAR.

PROPOSED MOTION:

THE TOWN COUNCIL OF THE TOWN OF VERNON IN ACCORDANCE WITH THE PROVISIONS OF SECTION 12-144a OF THE CONNECTICUT GENERAL STATUTES, AUTHORIZES THE COLLECTION OF MOTOR VEHICLE TAXES DUE AND PAYABLE IN ONE INSTALLMENT.
