

# Indoor/Outdoor Full Contact Sports Opt-In Form

Updated 4/22/2021

This form is to be used by a school located in a county designated as High Risk or Extreme Risk to notify of its intent to opt in to offer indoor/outdoor full contact sports for the 2020-21 school year in accordance with the Oregon Health Authority's Sector Guidance – Indoor Recreation and Indoor Fitness Establishments. Once final, post this form to your school or district website and a link to it will then be sent to ODE.

In Lower Risk and Moderate Risk counties, practices and games for indoor/outdoor contact sports can resume following health and safety guidance to be issued by the Oregon Health Authority.

In High Risk and Extreme Risk counties, where COVID-19 remains more widespread, schools and other sports organizations can opt-in to resuming indoor/outdoor full contact sports with additional protocols in place. In such counties, sports organizations must offer on-site responsive testing for symptomatic individuals and close contacts, contact information for contact tracing, and a waiver identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19. Schools in Extreme and High Risk counties must also have at least limited in-person instruction occurring, with the goal of achieving hybrid or full in-person instruction for students this school year. Schools must also be in compliance with state guidance for COVID-19 testing.

- We have submitted our test registrations for our comprehensive high schools and have test kits.
- Our school athletic trainers are serving as our test administrators and test reporters.
- We have a distinct and detailed check-in process for practices and for games. Our coaches and meet management handle the duties of screening.
- All participants will sign a waiver for testing.
- Should a screener notice symptoms, we will offer the self-administered test and apply the quarantine guidelines as indicated in the OHA's testing guidance.
- Cohorts in contact with the affected participant or presumed case will follow OHA guidance on when to return.
- We will work with OHA and Washington County Health in regards to communication in the event of a positive case.

- Check in Process
- A) Protocols for BSD Schools
- 1. Check in process - Masks required and Social distancing of at least 6 feet followed.
- 2. QR code or similar used to check-in anyone involved in a practice and/or contest. (Approved staff will oversee this process)
- a. Onsite/Offsite Athletes will use one entrance/one exit that uses QR code or similar for Covid 19 check-in and check-out. QR code questions will be in-line with current OHA and BSD guidelines.
- b. Tracking document for each school is overseen by Athletic Trainers, Athletic Directors and, Athletic Assistants)
- c. All athletes, coaches, and support personnel must wear a mask at all times.
- d. Athletes are required to provide their own water bottle.
- 3. Visiting Schools are responsible for check-in of their Athletes/Coaches/Administrators prior to each contest.
- 4. Officials
- a. All officials will go through the check-in and check-out protocols for BSD upon arrival and departure.
- 5. Miscellaneous Items
- a. Restrooms will be available for athletes/coaches and officials.
- 6. Locker Rooms will be available for practices or contests following capacity and supervision requirements.
- 7. Water fountains are not available and athletes will be required to bring their own water.
- 8. Transition protocol, from one scheduled event to the next, will be in place if multiple events are happening on a site. This would potentially involve separate entries/exits and/or staggered entries/exits.
- 9. Hand sanitizer should be plentiful and available to individuals as they transfer from place to place. They will be part of the check-in and check-out process.
- 10. Custodial staff will be involved in the cleaning of area(s) that are required by BSD.

# **Student-Athlete Waiver**
