Pre-Kindergarten: Continue in-person every day

Elementary (Grades Y5 - 6): Home-based (full Virtual) for students and parents who selected this option. Homeroom full in-person Y5-4 for students and parents who selected this option. Creekside students on a hybrid next week and phase in all students after April 19th.

Middle School (Grades 7 - 8): Home-based (full Virtual) for students and parents who selected this option. Homeroom (Hybrid) for students and parents who selected this option will continue on hybrid. Mill Creek students on a hybrid next week and consider phase in all students after April 19th on a 4 day schedule.

High School (Grades 9 - 12): Home-based (full Virtual) for students and parents who selected this option. Homeroom (Hybrid and Virtual combo) for students and parents who selected this option. The week of April 12th will have virtual on M 4/12 and F 4/16 with in-person testing schedule Tu-Th. DHS students on a hybrid next week and consider phase in all students after April 19th on a 4 day schedule.
