



### Nyob Zoo Txog Cov Yim Neeg:

Wisconsin cov me nyuam xyaum kawm Lus Askiv (ELLs) hauv cov qib K-12 yuav tau ua daim ntawv ntsuam xyuas ACCESS rau cov me nyuam ELLs thaum lub Ob Hlis 22 – lub Plaub Hlis 30, ncuu sij hawm ntsuam xyuas. Daim ntawv ntsuam xyuas ACCESS rau cov me nyuam ELLs yog ib daim ntawv ntsuam xyuas uas muab cov ntsiab lus hais txog qhov cov me nyuam kawm ntawv mloog tau, hais tau, nyeem ntau, thiab sau tau Lus Askiv zoo li cas rau cov tsev kawm ntawv thiab cov yim neeg. Daim ntawv ntsuam xyuas ACCESS rau cov me nyuam ELLs raug kee los ntawm Xeev (Wisconsin State Statute s. 115.96 (1)) thiab Tsoom Nom Tswv (20 U.S. Code s. 6311) txoj caiv kom ua. Thaum cov me nyuam kawm ntawv ua Xeev cov ntawv ntsuam xyuas nws yuav pab tau cov tsev kawm ntawv los txiav txim xyuas qhov tus kab mob tau cuam tshuam tus me nyuam txoj kev kawm li cas. Kev ntsuam xyuas cov me nyuam kawm ntawv nyob rau txoj kev muaj vaj huam sib luag tseem ceeb vim yog kev paub meej txog qhov kev kawm ntawm cov me nyuam kawm ntawv txhua tus yog kauj ruam thib ib hauv txoj kev kaw cov kev kawm tau sib txawv. Peb yuav tsum paub meej seb tseem muaj cov kev kawm tau sib txawv twg, cov kev kawm tau sib txawv muaj coob npaum li cas, thiab seb cov kev kawm tau sib txawv twb muaj ntev li cas lawm. Peb lub tsev kawm ntawv teem rau tuaj ua daim ntawv ntsuam xyuas ACCESS rau cov me nyuam ELLs rau \_\_\_\_\_.

Qhov kev ntsuam xyuas tus kheej tuaj ua yog tib txoj kev uas peb yuav siv tau rau xeev cov ntawv ntsuam xyuas. Lub tuam txhab uas tsim daim ntawv ntsuam xyuas tsis muaj qhov cia mus nyob rau ib qhov chaw ua (hauv computer/online). Kev ua nyob rau ntawm qho chaw ntsuam xyuas kom muaj qhov muab rau ua tau raws tus qauv uas xws li kev muaj vaj huam sib luag nkag mus siv tej technology thiab mus siv tau cov chaw ntsuam xyuas zoo tshaj plaws, ceev tau daim ntawv ntsuam xyuas zoo, thiab siv tau (validity).

Peb tab tom muab txhua qhov kev faj seeb los xyuas meej kom muaj qhov chaw ntsuam xyuas ruaj ntseg. Peb ua raws cov txheej txheem kee kom ua los ntawm Cov Chaw Tswj Kab Mob thiab Feem Kev Noj Qab Haus Huv (DHS) xws li kev nyob sib nruq, cov caij nyoog ywj thiab ib sij muab tshuaj so me nyuam tej chaw thiab tej cuab yeej. *[Thov ua kom haum rau nej lub tsev kawm ntawv cov laj txheej thiab/los yog ib daim ntawv npaj hauv zos.]* Cov me nyuam kawm ntawv yuav tsum xyuas meej kom nqa tau nej lub computer, txoj hlua txhab roj (charging cord), thiab yog tias nyiam siv ces nqa ib lub mouse tuaj. Yuav muab cov mloog pob ntseg so tshuaj tib si rau nej siv.

Daim ntawv ntsuam xyuas ACCESS rau cov me nyuam ELLs muab ntsuam xyuas cov me nyuam kawm ntawv raug txheeb tau tias yog Cov Me Nyuam Xyaum Kawm Lus Askiv (ELs) txhua xyoo los txiav txim xyuas lawv duus kev paub Lus Askiv npliag (ELP) thiab xyuas meej koj lawv ua tau nyob hauv qhov kev paub Lus Askiv npliag. Yuav muab ib daim los yog ntau daim ntawv ntsuam xyuas ntxiv txhua hnuv nyob rau peb lub sij hawm xaiv tseg ntawd. Thov xyuas meej kom cov me nyuam kawm ntawv noj qab nyob zoo ua ntej xa lawv tuaj rau tom tsev kawm ntawv. Ceev cov me nyuam kawm ntawv nyob tom tsev yog nws lawv mob lawm los yog tau mus nyob sib ze rau tej tus neeg mob COVID-19. Cov me nyuam kawm ntawv tsis nyob hauv tsev kawm ntawv rau cov hnuv ntsuam xyuas yuav raug muab teem dua rau tuaj ua daim ntawv ntsuam xyuas ua ntej kaw ncuu sij hawm ntsuam xyuas.

Nrog ua ke no yog daim ntawv piav txog *daim ntawv ntsuam xyuas ACCESS rau cov me nyuam ELLs rau Cov Yim Neeg* uas muab cov ntsiab lus hais txog qhov kev ntsuam xyuas ntxiv xws li nws lub hom phiaj, cov qhab nee yuav muab rau, thiab qhov cov qhab nee yuav muab siv li cas. Qhov kev ua nyob hauv daim ntawv ntsuam xyuas ACCESS rau cov me nyuam ELLs yuav tsis cuam tshuam tus me nyuam kawm ntawv cov qhab nee kawm. Thov pab hais kom cov me nyuam kawm ntawv ua daim ntawv ntsuam xyuas li qhov tiag tiag thiab ua qhov zoo tshaj plaws li qhov lawv ua tau. Cov ntsiab ntsuam xyuas tau ntawm cov ntawv ntsuam xyuas no yuav raug muab siv los pab tsev kawm ntawv cov neeg ua hauj lwmm muab kev txiav txim xyuas hais txog kev npaj, kev qhia ntawv, thiab cov kev pab los txhawb cov me nyuam kawm ntawv.

Xeev Wisconsin txoj cai tso cai rau cov niam txiv/cov saib xyuas los xaiv seb yuav cia lawv tus me nyuam koom rau hauv xeev qhov kev ntsuam xyuas los tsis cia.
