General Conditions, Tuition Refund Insurance, and Payment Procedures

Each year, Webb School asks families to renew their student's enrollment during the reenrollment period, typically a two-week period beginning in mid-February. New families will be offered an enrollment contract immediately after re-enrollment ends. At the time of enrollment or reenrollment, a non-refundable deposit is required.

<u>After submitting an enrollment contract, families are obligated to pay tuition and fees for the entire school year UNLESS the family notifies both the Director of Financial Services and the Director of Admissions prior to June 30, 2021</u>. After this date, all families will be obligated to pay for the full year's tuition and fee whether or not their student is fully-enrolled. This is necessary because budgets are driven by enrollment and are finalized for the full year by July 1.

Tuition Refund Insurance (TRI)

Tuition Refund Insurance (TRI) will be offered to all parents. This insurance offers an opportunity to insure that some tuition and fees will be paid under the terms of the policy in the event the Student is unable to complete the school year. Parents paying by the monthly payment plan and students receiving financial aid must enroll and pay for TRI coverage. The Parent authorizes the School to collect any claim or payment due under TRI and to credit the amount collected to the Student's account. However, to the extent that tuition and fees may not be fully covered by TRI, the Parent remains responsible for full payment to the School. Families who elect to pay in two installments must notify the Business Office by July 31, 2021 if they wish to decline Tuition Refund Insurance.

Payment Procedures: Payment plans and payment of other charges

The first charge for tuition and lunch fees will occur on or about July 1, 2021. Deposits will be applied to the July billing. Families may pay in full in July; elect a two-installment payment plan (July and November); or elect a tenmonth payment plan (July 2021 through April 2022). In addition to tuition and lunch fees, parents agree to pay all variable charges incurred by students for school programs, events, travel, materials, supplies, etc. Webb utilizes a third-party vendor to facilitate all student billing. Payments may be made via check, credit card (fees are applied), or ACH draft.

Terms of Account

The enrollment contract details the exact terms of enrollment as it relates to payment of tuition, fees, and other costs incurred. Webb School strongly encourages all families to print their student's executed contract and retain a copy. Ultimately, all families must meet their obligations to the School in order to ensure their student continues to have all privileges afforded Webb School students.

If a student's account is more than thirty (30) days overdue, there will be a late payment fee of 1.5% per month (18% APR) on the outstanding balance. Further, when a student's account is overdue, Webb School reserves the right to suspend a student's privileges to attend class, take field trips, sit for examinations, participate in extracurricular activities like athletics, make purchases in the School Store, receive grades or transcripts, or graduate. Again, we urge families to meet their obligations to ensure their student's Webb School experience is not interrupted.

Special Circumstances

Webb School reserves the right to remove a student at any time if, in the judgment of the School, that student's conduct, progress, influence or industry either on or off campus is not in keeping with Webb School's accepted rules and regulations.

There will be no refund of tuition when such enforced withdrawal occurs; in addition, any unpaid balance remains payable in full in accordance with the agreed upon payment schedule prior to the release of any transcripts and other official confirmation of a student's enrollment at Webb School.

In the event that Webb School obtains information after June 30, 2021 and before August 1, 2021 that suggests the inappropriateness of the student's attendance, Webb School may withdraw an offer of reenrollment or enrollment, and void the executed contract.

Financial Aid

The Admissions Office coordinates the application and allocation process for all financial aid. All current and prospective families are invited to contact the Admissions Office about the availability of funds and information about the financial aid application process. Please note that financial aid funds are limited, and all families are encouraged to contact the Admissions Office immediately if interested in applying.

To receive financial aid, a family must meet these requirements: all student accounts must be current, students must be in good standing academically, and students must not have disciplinary infractions on file which could prevent the student from maintaining enrollment through graduation. Further, there is a thorough application process which includes a third party application through School & Student Services (SSS), submission of IRS Form 1040s for the last two years, and all supporting documentation as outlined by the Admissions Office. Financial aid is allocated annually, and financial aid awards will be applied in two installments reducing the tuition and fees billed. Families will be billed according to the remaining balance due after financial aid awards are credited.
