Pledge of Allegiance was recited.

Mayor Daniel A. Champagne called the Virtual Public Hearing and Annual Town Meeting to order at 7:00PM.

Town Clerk, Karen C. Daigle read into the record the legal notice of the Public Hearing and Annual Town Meeting that was published in the Journal Inquirer on April 16, 2021

Mayor Daniel A. Champagne called for nominations for a Moderator. Brian Motola, seconded by Polly Schaefer, made a motion for John Leary as Moderator. The motion carried unanimously by voice vote. Mayor Daniel A. Champagne declared John Leary as Moderator.

Moderator John Leary explained that the Annual Town Meeting will serve as a Public Hearing for comments on the Fiscal Year 2021-2022 Budget and explained the rules of voting eligibility.

Moderator John Leary asked if anyone would like to comment on the budget.

No public comments were made.

Moderator John Leary closed the Virtual Public Hearing at 7:09PM

Moderator John Leary asked for the following motion to be put on the floor:

PROPOSED MOTION

MOVE TO ADOPT THE TOWN OF VERNON BUDGET FOR FISCAL YEAR COMMENCING JULY 1, 2021 AND ENDING JUNE 30, 2022 IN THE AMOUNT OF \$95,889,058.00 FURTHER AUTHORIZES THE VOTING PORTION OF THE VIRTUAL ANNUAL TOWN MEETING TO BEGIN IN THE PARKING AREA OUTSIDE ROCKVILLE HIGH SCHOOL AUDITORIUM. VOTING IS INDICATED BY A SIMPLE THUMBS UP OR DOWN. VOTING CONCLUDES AT 8:30PM.

Polly Schaefer, seconded by Maryanne Levesque, so moved the motion.

Moderator John Leary called for a recess at 7:09PM until the completion of the vote.

The Annual Town Meeting reconvened at 8:31PM.

Moderator John Leary announced that the motion carries with 63 in favor and 3 opposed.

Linda Gessay, seconded by Maryann Levesque, made a motion to adjourn the Annual Town Meeting at 8:33pm. Motion carried unanimously by voice vote.
