A. College and Career Readiness – Katie Wallace

1. Seal of Biliteracy

The requirements and steps to obtain the State Seal of Bilingual Literacy were explained in detail. This seal is available at middle and high schools by taking the exam and meeting the grades requirements.

2. Starting Smarter & 3. ELPAC

A presentation titled Pathway to Success and College Readiness for English Learners was given to cover both agenda items ii and iii.
