The S.T.A.R. One-to-One Laptop Manual

I. Vision

Susquehanna Township School District is committed to providing every student a world class education every day, in every way. Striving to be a leader in innovation and technology, all middle school students will be assigned an individual laptop computer to utilize daily while at school. Through **STMS S.T.A.R.**, students will expand their sources of research, find meaningful real-world assignments, seek out legitimate digital information to solve real world problems, create and collaborate with their peers, teachers, and subject area experts in new and meaningful ways.

II. What is One-to-One?

Our One-to-One initiative gives every middle school student access to their own personal laptop computer and digital resources for every class throughout the school day. **S.T.A.R.** creates an equitable opportunity for all students leveling the technological playing field.

III. Terms of Laptop Loan

Each laptop will be assigned to an individual student number and the serial number of the laptop will be recorded. The laptop issued to the student will remain with the student throughout the school year or until the student withdraws from STSD. Student computers will not leave the school building. The laptop and all accompanying accessories remain the property of the Susquehanna Township School District (STSD). **Laptop Insurance Program**: All students will be enrolled into the STSD **One2One Laptop Insurance Program.** AJG's One2One Insurance Program will be provided <u>free of charge</u>. Please see the insurance program summary document that is found in the Appendix of this manual.

IV. Picking up and Returning Student Laptops

Students will remove their computer from the computer cart in their Advisory class. Students will also pick up their computer bags in their Advisory class. All computers are to be carried in the computer bags throughout the day. Only materials related to computer use may be stored in the computer bag, for example, headphones, ear buds, or a wireless mouse. Students will report back to their Advisory classroom at the end of the day to return their computer to the computer cart for charging. Students will also return their laptop computer bags at the end of the day. Teachers will develop a process to ensure an efficient and safe process for daily computer pick up and return.

V. Taking Care of Your Laptop

Laptop computers remain the property of STSD and are on loan to the students. Students are responsible for the general care of the laptop that they have been issued. Laptops that become damaged or fail to work properly must be reported to the student's Advisory teacher who will submit a ticket to Tech Support.

General Precautions:

- Student laptops will only be issued to students who have a signed Acceptable Use Policy (AUP) form on file.
- The AUP guidelines must be followed always.
- Students must not lend their computers or swap computers and should only use the computer that is assigned to them.
- Students must keep their laptop passwords private.
- Follow the **SOAR** expectations when using your computer. Always
- carry your laptop in your computer bag. Computers should not leave the classrooms without being placed into the computer bags.
 Only materials related to computer use may be stored in the computer bag.
- Keep food and liquids away from your computer.
- Stickers are not permitted to be applied to student laptop computers or computer bags.
- Computers should never be left unattended.

• Students must shut down their computers before returning the laptop to the computer cart at the end of the day.

VI. Laptop Screen Care

The laptop screens can be damaged if subjected to rough treatment. The screens are sensitive to damage from excessive pressure on the screen.

- Avoid placing pressure on the lid of the computer.
- Keep objects off the keyboard before closing the lid.
- Avoid pushing on the screen with your fingers.

VII. General Computer Use

- Students are responsible for maintaining and backing up their files and documents.
- No changes can be made to the computer's standardized software configuration.
- Unapproved software, apps and games are not to be downloaded on student computers.
- Internet activities and laptop history will be frequently monitored to ensure and verify appropriate use.
- Each laptop has identifying labels, including a serial number and asset tag. These tags must not be altered or destroyed.
- 1:1 device damage is a Level I offense listed in our STSD Student Success Manual and will result in disciplinary consequences.
- Laptop sound should be muted unless permission is given by the teacher. Headphones/earbuds may be used in class when listening to the laptops as necessary. It is suggested that students provide their own headphones/earbuds.
- Printing from laptop computers will be directed by the teacher. Teachers will provide directions on how to submit assignments electronically.
- Students should use the district provided OneDrive cloud storage to store all files and documents. It is important to create an organized digital file system for files and documents. Any files or documents saved on the desktop or hard drive of the laptop will be lost in the event of a hardware failure.

VIII. Internet Safety

As part of the STMS curriculum in our **Digital Citizenship and Technology** class, students will be instructed about appropriate online behavior and important components of digital citizenship, including interacting with other individuals on social networking websites and in chatrooms.

- Students should report any unauthorized internet activity to a teacher.
- Notify a teacher immediately if you accidently access an inappropriate website.
- Report cyberbullying or cyber harassment immediately to a teacher or administrator.
- Never access or transmit racist, abusive, threatening, sexually explicit or inflammatory content.
- Observe all copyright laws; do not claim authorship of work copied from a website or from any other source. Accurately cite all sources of information.
- Protect your user account by keeping your password secure and logging off or locking your computer when not in use. All email and internet activity is the responsibility of the individual whose account is logged in to the computer at the time of the activity.
- Protect personal information. Never give your full name, address, phone numbers, passwords or social security number.
- Privacy: there is no expectation of privacy regarding the contents of the computer files or communication using any school owned laptop computer or network. STSD reserves the right to review, monitor, investigate and restrict information stored on or transmitted via school laptop computers.
