Minutes of Regularly Scheduled meeting of the Vernon Traffic Authority scheduled for February 14, 2008.

Meeting called to order at 7:00 p.m. by Chairman Kenny

Chairman Kenny requested the Authority deviate from agenda and hear application of Site Plan review for 1189 Hartford Turnpike. No objections.

Agenda #4: Site plan review – 1189 Hartford Turnpike, Developer represented by: Duane Jones Sr. 238 Mile Hill Road, Tolland CT.

Site plan review accepted with following stipulation: The curb cut for the exit be reduced in width to facilitate one way traffic at west end of the project. East curb cut being designated as entrance only. Proper signage would be required to facilitate traffic movement consistent with above requirement. West exit would be required to have “exit only” signage consistent with MUTCD requirements and stop sign with stop bar.

Second crosswalk east of park not approved due to concerns of driver confusion. The request for the speed limit signs would be referred to Police Department and Department of Public Works for collaboration regarding location.
