PROPOSED MOTION #1a

PURSUANT TO THE VERNON TOWN CHARTER CHAPTER XII, SECTION 6 "Duties of the Town Council on the budget", THE VERNON TOWN COUNCIL HEREBY SETS THE TAX RATE FOR THE FISCAL YEAR JULY 1, 2012 THROUGH JUNE 30, 2013, AT ______ MILS UPON TAXABLE PROPERTY IN THE TOWN OF VERNON AND SIGNS THE TAX WARRANT FOR SAID FISCAL YEAR.

THE TOWN COUNCIL HEREBY MOVES TO PRESENT THE TOWN COUNCIL APPROVED BUDGET FOR FISCAL YEAR 2012-2013 IN THE AMOUNT OF \$80,599,160.00 TO THE ELECTORS AND OUALIFIED TAXPAYERS TO VOTE ON BALLOTS AT THE BUDGET SCHEDULED FOR REFERENDUM TO BE CENTER 375, 375 **HARTFORD** AT TURNPIKE, VERNON, CONNECTICUT, BETWEEN THE HOURS OF 6:00 AM AND 8:00 PM, AND TO AUTHORIZE AND DIRECT THE TOWN CLERK TO PUBLISH A WARNING OF SAID REFERENDUM AT LEAST FIVE DAYS BEFORE THE REFERENDUM AND TO PHRASE SUCH ITEM IN A FORM SUITABLE FOR PRINTING ON SUCH PAPER BALLOTS OR BALLOT LABELS IN ACCORDANCE CONNECTICUT GENERAL STATUTES 7-7 AND OTHER LAWS.
